## Ground Breaking for Pohnpei International Airport Expansion

On April 18, 2008 dignitaries and onlookers assembled to take part in a groundbreaking ceremony at the Pohnpei International Airport.

The project will be constructed in three phases according to the pictures on display at the groundbreaking ceremony. In the

first phase a new generator building will be constructed, along with new twenty five foot runway shoulders, a new runway overlay, an ARFF (Airport Rescue and Fire Fighters) Building located to the side of the runway at its approximate midway point.

The second phase of construction will include a new taxiway overlay, new shoulders and fillet, new piles, and a new apron overlay.

The project will be topped off in the third phase by a new "RW9" turnaround on the west end of the runway along with a new security perimeter road and fence for the airport.

The engineering and design was performed by GMP Hawaii Incorporated.

## High Rice Prices? President Mori Calls on FSM Citizens to Eat More Local Food

**Palikir, POHNPEI** - President Manny Mori has called on the people of the FSM to be conscious of the rising price of rice in world markets, and has urged FSM citizens and residents to consume more local foods instead.

President Mori was reacting to international news reports that the price of rice has increased by as much as 50 percent in the past year due to world-wide shortages caused by drought and other natural and economic changes in key production countries.

The President noted that Australia is reported to have suffered a catastrophic 90 percent reduction in rice production due to the recent drought conditions there.

Even major Australian companies are importing rice from China and other South East Asian producers for sale within Australia. This has had an impact on FSM because a large portion of FSM rice is imported from Australia.

President Mori noted that as a result of world-wide and regional shortages, the price of rice has risen considerably in most areas and supplies are sometimes short even for those willing to pay higher prices. This is having a global impact on consumers in poorer countries in particular as rice is a major portion of their regular diet.

"We cannot control the world price and supply of rice," President Mori said, "but we, the FSM should not panic and feel desperate as long as we have the abundance of local foods available to

us."

President Mori called on businesses in FSM not to exploit the situation by raising prices unreasonably. He urged businesses to instead work closely with local farmers to increase the supply and quality of local food for sale locally at reasonable prices.

President Mori said the people of the FSM are very fortunate that our islands still produce an abundance of local food crops including breadfruit, bananas, taro, yam, sweet potato, cassava and a range of local food plants that are more nutritious and tastier than rice.

The President also called on government and community leaders, including in churches, schools and medical facilities, to show the lead by personally consuming more local foods and reducing

their reliance upon rice as a staple food and to educate other members of the community, especially young people, about the health value, growing technology and preparation methods of local food.

"For too long our children have been fed on rice as a staple food because of the convenience of preparation and storage. We have neglected our responsibility and even contributed to their lower health standards by failing to teach them to appreciate the natural food bounty of our islands," President Mori said.

"Now, the rise in the price of rice gives families greater incentive to do the right and healthy thing", President Mori added.

President Mori also urged tourists and foreign residents of the FSM to also sample and use more local food items in their meals.

## World TB Day – CDC Official in the FSM to Promote Awareness

**Federated States of Micronesia** - In the late 1800's TB killed one in seven people in the United States. On March 24, 1882, Dr. Robert Koch announced the discovery of the tuberculosis bacillus. On March 24, 1982, the World Health Organization established World TB day as an international effort to raise awareness about the international health threat presented by tuberculosis (TB). It is a day to recognize the collaborative efforts of all countries involved in fighting TB. TB can be cured, controlled, and, with diligent efforts and sufficient resources, eventually eliminated.

On March 24, 2008, Phillip M. Talbot, Deputy Director, Division of Tuberculosis Elimination, National Center for HIV/AIDS, Viral Hepatitis, STD, and TB Prevention of the Centers for Disease Control was in the FSM to continue the charge toward more international awareness of

the disease.

He presented a 73 page PowerPoint presentation to fifty to sixty people in attendance at the Forum Lecture series at the FSM - College of Micronesia. The Forum Lecture Series is a cooperative effort of COM and the US Embassy. He and local representatives from the Health Department also conducted radio, and newspaper interviews throughout the nation in an effort to get the message out about Tuberculosis in the FSM.

In the United States, CDC provisional numbers show that 13,293 people out of 301 million have the disease or 4.4 people per 100,000 of population. In the FSM the ratio is 14.4 times higher than that at 61.1 per 100,000. Again, these numbers are provisional and according to Mr. Talbot it could be that the numbers in the FSM could rise. Due to the nature of the FSM with its many outlying islands there could be people with the disease that experts don't yet know about.

### What is TB?

Tuberculosis usually attacks the lungs but can also spread to other parts of the body. It is transmitted when the bacillus becomes airborne through human activities like coughing, sneezing, or even singing. A person contracts TB by breathing in the same air as a TB infected person with whom they live in close quarters for a long period of time.

It's symptoms include a persistent cough that lasts for longer than two to three weeks, a fever, weight loss, night sweats, and a loss of appetite. If not treated it can be deadly but TB IS CURABLE!

Officials working to eliminate the disease in the FSM wanted to stress that the disease is curable.

### MDR and XDR?

He said that it is vital that patients with the disease continue treatment until the end. Curing the disease is tough on the patient who must receive a shot every day for six months. Their urine and tears will likely turn orange and they will likely feel sick, sometimes very sick but the medicine that seems to make patients so sick is actually killing the disease and not the patient. Patient's who stop the treatment before the disease is actually cured will likely feel better but they run the risk of developing and spreading drug resistant strains of the disease.

It's not fair really. Patients who develop TB do so through no fault of their own but once they do it is their responsibility to be sure they are treated fully even though that treatment causes personal suffering.

Drug resistant TB can range from mono-resistant (MDR) strains that are resistant to the "first line of defense" medications to multi-resistant which is a strain of TB that is extensively drug resistant (XDR).

### Night and Day...

Mr. Talbot congratulated the effort

of the Tuberculosis program in the FSM. He said that the difference in the program between 2000 and 2008 is like night and day. Dr. Mayleen Jack Ekiek is the Manager of the FSM National TB Program in the Department of Health and Social Affairs. She said that local staff efforts, laboratory facilities and medical consultations have gotten much better since she began in the program in 2002. She wasn't congratulating herself, she was congratulating the efforts of those in charge of the local programs in each of the States.

Rupihner R. Defang is the TB Program Coordinator for the Division of Primary Health Care for Pohnpei State Health Services. In addition to a locally produced video that has been aired on the local cable system the Department has health professionals that travel into the field every single day.

With the importance of complete treatment of the disease Health Professionals working in the TB Program in each of the States each day visit patients who have the disease for directly observed treatment. Talbot said that without that type of treatment many patients might abandon their battery of treatments which would not only put them at risk but anyone who might come into close contact with them.

Every baby born in the hospitals of the FSM are vaccinated against the disease. TB medicines are free in the FSM.

### Detection...

Officials say that a person can be infected with TB and be able to pass it on but not develop symptoms. They said that everyone should be time tested. The test is relatively painless, just a quick poke four times. Results can be seen a few days later. If the red dots are still just red dots there is no TB. If the dots left on the skin have a reaction to the test and have swollen and joined together the patient needs treatment.

Screening is important, Talbot said. "MDR TB is here and if we aren't careful XDR TB is right around the corner."

## Launch of New Border Management System in Airports and Immigration Offices in FSM

### The Australian Embassy

On 9 April 2008, the Australian Ambassador, H.E. Susan Cox, hosted an official ceremony at Pohnpei airport to mark the completion of the FSM Improved Border Management System in Chuuk, Kosrae, Pohnpei and Yap.

At the ceremony, Ambassador Cox commented that, "The new computerised system would not only strengthen border security but also improve passenger processing times using automatic passport readers and generate national statistics to assist tourism and government planning."

FSM Secretary of Justice, Maketo Robert, accepted a

plaque from the Australian Government to commemorate the successful installation of the new systems which now networks the national immigration office in Palikir, the four state immigration offices, the four international airports and passenger ships.

Secretary Robert thanked Australia for sharing its technology and technical expertise with the FSM noting that the new systems will greatly expand the country's border management capability.

The Australian Ambassador acknowledged the project as an important example of development cooperation between the Governments of

Australia and FSM. The project was jointly funded by both Australia (approx. USD\$800,000) and the FSM (approx. USD\$150,000). FSM's contribution was to upgrade the airports and Immigration offices to prepare for Australia's technological contribution.

Also present at the ceremony was Mr David Coombe from *Natural Systems*, the Australian immigration systems company that provided the project software and support. Mr Coombe noted the delays with installing the Border Management System in Yap following Typhoon Sudal in April 2004. However, he expressed his satisfaction that all four states are finally op-

erational with the new System.

Other companies involved in the project included Pohnpei-based *Asumen Ventures Incorporated (AVI)*, *FSM Telecom* and *Dynjab Technologies*.

The ceremony was also attended by the Acting Secretary of Foreign Affairs, Mr Kandhi Elieisar; Chief of the Division of Immigration and Labor, Mr Mohner Esiel; Chief of Police, Mr Pius Chotailug; Immigration Program Manager (IT), Mr David Wolphagen; General Manager of Pohnpei Tourism Office, Mr Edgar Santos; and AusAID Program Manager, Mrs Emma Tiaree.

### Police Commission Internal Investigator

#### GENERAL PURPOSE:

Under general supervision of the Police Commission, reviews, analyzes, plans, and conducts investigation into allegations of police misconduct, produce detailed written reports of all investigative activities, conduct in depth analysis of all officer involved shootings and deaths of persons that occur while in police custody; prepare written and oral reports of officer involved shootings and custody deaths to be used during the various review process within the Department of Public Safety.

#### DISTINGUISHING CHARACTERISTICS:

This is a highly skilled investigative position. An employee occupying position of this class is responsible for performing complex and difficult investigations into allegations of police misconduct.

Additionally, the employee in this classification conducts policy reviews and analysis of all incidents in which police officers use deadly force and cases in which a person dies while in police custody.

#### ESSENTIAL DUTIES AND RESPONSIBILITIES:

Any one person in this class may not perform all the duties listed, nor do the listed examples of duties include all similar and related duties that may be assigned to this class.

1. Investigate allegations of misconduct by analyzing the allegations, evidence, and investigative outcomes consistent with the Department of Public Safety's rules and procedures, determine the specific policy violations that apply to each allegation of misconduct and identify the members who are suspected of violating those policies as well as identifying members who are potential witnesses.
2. Conduct policy reviews and analyses of incidents in which police officers use deadly force and cases in which a person dies while in police custody, prepare comprehensive reports for use in the review process that determines if the involved members acted within the policies of the Department of Public Safety.
3. Develop an appropriate investigative strategy to identify relevant evidence.
4. Conduct interviews with witnesses who may include complainants, citizens of the public, and with those who are suspects of alleged misconduct.
5. Identify allegations of contain elements of criminal behavior and refer those cases to the Director of Public Safety for investigation.
6. Analyze all gathered information; prepare reports and presentations on the outcomes and activities of the investigation conducted and deliver presentations to the Police Commission and Director of Public Safety,
7. Consult with members of the Police Commission and give input regarding allegations or misconduct.
8. Respond to requests from the citizens of the public for additional information on investigations of misconduct.
9. Other duties as assigned by the Police Commission and the Department of Public Safety.

#### OTHER DUTIES:

1. Attend Police Commission regular and special meetings.
2. Prepare and deliver presentations for training and other purposes.
3. Conduct research on best practices of other law enforcement agencies.

#### MINIMUM QUALIFICATIONS:

##### Knowledge of:

1. Department of Public Safety's rules and regulations;
2. Generally accepted investigative practices and procedures;
3. Applicable laws and judicial rulings affecting Internal Affairs processes;
4. Effective community and public methods and practice;
5. Grammar, syntax, organizing complex ideas into coherent writing

##### Ability to:

1. Conduct thorough, objective investigations of police misconduct;
2. Present the results in both written and oral formats
3. Understand how policy of public safety organizations applies to each allegation of misconduct;
4. Communicate clearly both orally and in writing.
5. Maintain confidentiality regarding the activities conducted by the Internal Investigator's Office.
6. Analyze allegations of misconduct within the context of the Department of Public Safety's rules and procedures;
7. Use word-processing, presentation and other office software as needed
8. Use a digital voice recorder and the accompanying software.

##### Training and Experience:

A typical way of obtaining knowledge, skills, and abilities outlined above is graduation from a four year college or university; at least five years of progressively responsible experience conducting internal organizational audits or investigations of misconduct or criminal behavior. Experience in law enforcement and/or a public agency is preferred.

##### Licenses, certificates, special requirements:

A valid state driver's license.

#### PHYSICAL AND MENTAL DEMANDS:

Persons with disabilities may be able to perform the essential duties of this class with reasonable accommodations. ## Admiral Keating Meets with FSM's President Mori

**Palikir, POHNPEI (FSMIS)** - Navy Admiral Timothy J. Keating, head of the United States Pacific Command visited Federated States of Micronesia on April 8, 2008.

In a joint press statement President Mori told Admiral Keating that there is "very strong, very unique, very friendly relationship" between the two countries. This relationship enables the Micronesians to sleep comfortably at night, recognizing the peace and security this relationship provides.

Keating, Commander of U.S. Pacific Command, expresses on the same sentiment the close, longstanding security ties the United States and Federated States of Micronesia share.

Admiral Keating told President Mori that the strength of the two countries friendship is important to Pacific Command "it is the sort of relationship which woven together, form a very, very tight fabric of peace and stability all throughout the vast part of the world for which we are responsible."

He also noted the upcoming USNS Mercy hospital ship visit to Micronesia as part of Pacific

Partnership 2008. Hundreds of medical and dental professionals, some in the military and some civilian volunteers, will provide medical care for those either too far away from the care they need or unable to afford it.

Keating concluded by reassuring President Mori that Micronesia can depend on its longstanding friendship with United States "should you need help," regardless of the size, regardless of the time, regardless of the technical nature, if the United States Pacific Command can, we will."

We will be here as soon as asked for the assistance, whether it's day or night, humanitarian assistance or something requiring even higher military capability, he said. "It will be our distinct privilege to provide that service when we can." Commander Keating concluded

Also discussed in the meeting were FSM's ongoing Fiber Optic Cable efforts, and the military build-up in the neighboring Guam, to which both sides agreed would be beneficial to the FSM and would be another means to further collaborate on issues of

to Terrorism (CSRT) Course in Honolulu, Hawaii.

The FSM participants joined 61 other military and civilian participants from 31 countries throughout the Asia-Pacific Region who attended the three-week course.

Participating Countries were Australia, Bangladesh, Brunei, Canada, Egypt, El Salvador, India, Kenya, Laos, Madagascar, Malaysia, Mexico, FSM, Mongolia, Mozambique, Nepal, Pakistan, Papua New Guinea, Philippines, Poland, Republic of Korea, Russia, Singapore, Sri Lanka, Tanzania, Thailand, Tonga, Turkey, United States and Vietnam.

The CSRT course provides key states in the Asia-Pacific Region and other designated countries the operational and strategic level skills necessary to enhance their ability to combat terrorism and to cooperate with other regional nations.

The course is designed to build rela-

mutual interest.

The visit concluded with both sides reaffirming their shared interests and commitment to security and peace in the region.

Accompanying Admiral Keating and his delegation on the visit to the FSM Congress was Ambassador Miriam K. Hughes of the US Embassy in Kolonia. Along with Speaker Figir in the visit with the Admiral were the following Senators: Chairman Peter Sitan - Committee of Judiciary and Governmental Operations; Chairman Dohsis Halbert - Committee on Ways and Means; and Chairman Nelson A. ## FSM Maritime Law Enforcement and Legal Issues Workshop

Co-operation and co-ordination were the key themes discussed during a two day marine enforcement workshop held in Pohnpei last week.

Representatives from a number of maritime related organizations and FSM National government departments attended the workshop where building the capacity of the National Police Maritime Wing was high on the agenda. The twenty participants at the workshop were drawn from the FSM National Police, Division of Immigration, Customs, Department of Justice, Pohnpei State Police, NORMA and the Royal Australian Navy.

The Australian Ambassador to the FSM, RMI, Palau and the CNMI, Her Excellency Ms Susan Cox, addressed participants during the opening of the workshop which

was held at the Seabreeze Hotel in Kolonia on Wednesday. Ambassador Cox highlighted the long and positive relationship Australia has established with the FSM and in particular the support provided through Australians Defence Cooperation Program and the Pacific Patrol Boat Project.

In the spirit of support and co-operation, the Australian Defence Force (ADF) through the Pohnpei based Australian Maritime Surveillance Advisor, Lieutenant Commander Mark Sorby, worked closely with FSM Chief of Police, Colonel Pius Chotailug to develop this important activity.

The workshop resulted in the development of a number of key outcomes and strategies designed to build capacity of FSM Maritime Wing which will allow them to perform operational activities in a safer more professional and effective manner.

Other important outcomes included enhancing legislation in relation to illegal fishing, immigration and customs and maritime security in addition to other crimes which are viewed as a risk to FSM national security. Lieutenant Commander Mark Sorby told the workshop participants there he hoped to identify appropriate support to assist FSM to

address the issues raised over the two-day meeting from relevant Australian and regional organisations.

Chief Chotailug told the *Kaselehlie Press* that increased training opportunities and information sharing capacities between relevant organizations were key outcome strategies developed.

**WENO, Chuuk**—From April 14 - 18, the FSM Substance Abuse and Mental Health Program met in the Truk Stop Hotel on the administrative island of Weno. “We are fortunate because this is the second time we have all the SAMH program in the FSM get together”, said Kerio Walliby, FSM SAMH Administrator who is stationed in Pohnpei. Representatives from the respective States of Kosrae, Yap, and Pohnpei arrived days earlier for the five-day session.

One of the guest speakers on the opening day was Chuuk Governor Wesley W. Simina. In his welcoming speech, Governor Simina emphasized the importance of preventing the use of drugs and other dangerous substance in Chuuk. “I wish you a successful annual meeting and if there is anything my office could do to help, please let us know.” Governor Simina also relayed a story about a shark and

man with a mental disorder named “Kaso” who, according to Governor Simina, jumped right into the water even knowing by seeing that a hungry shark was there. Fearless Kaso? Maybe.

Each representative focused on how to cope with substance abuse that sometimes leads to mental health disorders in some youths across the nation. Betel nut and tobacco were two items often discussed in the workshop. Representatives in the seminar included Chuuk Athletic Club, Inc. and SHIP/HOOPS both of which play an important role in the overall FSM SAMH program.

The seminar was held at the Hard Wreck conference room which also hosted a party in honor of the returning participants from Chuuk sister states. Suicide prevention was another topic discussed at the meeting whose theme was “To Live in a Safe, Drug Free Environment.”

## Alaska Internship for COM Fisheries Student

Alaska holds some of the finest fishing waters in the world. Every summer since 1999, one of students at the College of Micronesia has been selected to participate in a summer fishery internship program in Alaska. This year, it is a reality for Joeven Malwesou.

This will put Joeven aboard a commercial fishing vessel plying the waters of the Alaska Coastline for Salmon and Halibut this summer. Joeven, who grew up on Lamotrek Atoll in Yap; attended COM classes last year at Yap and this year is at the National Campus in Pohnpei. He is a Marine Fisheries major and was selected from seven finalists who were qualified for the program.

Joeven was asked about what are his thoughts on going to Alaska, a place quite different from FSM. He said, "I am very happy that they chose me to be the one to go for this summer 2008's Internship." Joeven stated that he is looking forward to: "Experience a very different climate, get to travel for a very long-distance away from the Federated States of Micronesia, see those Eskimos from Alaska, experience a summer without night or day, and to touch snow in real life. I welcome this chance to practice what I have learned from my instructors here at COM, especially, from my Marine Science classes."

The Internship is for three months of study, involvement, and work in a small commercial fishing venture in the fishing community of Sand Point, Alaska. This involves the student in flying over 7,000 miles from Pohnpei to the Alaska fishing site, some four weeks aboard a fishing vessel, and the use of longline gear for Halibut and set net sites for salmon. It also requires careful handling and care of several thousand "number one" quality fish for delivery to one of the most modern processing plants in the fishing industry. Additionally, it includes studies and lab work for a Fisheries Course; which is a part of the Internship.

The program pays for travel, licenses, warm clothing, gear required, and all living expenses involved. Additionally, upon completion of the internship at the end of the summer, the student receives over \$1,000 for his use with education.

Joeven Malwesou is the 11th student to benefit from this program. Last year's recipient was Elijah Tarofalmal, who is currently finishing his studies at COM.

This Internship is sponsored by COM and paid for by Professors Ray and Yen-ti Verg-in at the National Campus for COM, who fish in Alaska during the summers.





All the women are encouraged to learn from the Chinese agriculture technicians to start their own farming business at home.

One representative of the Pohnpei women council, on behalf of all the visitors expressed their gratitude to the Chinese government for the generous assistance over the years and the hospitality of Ambassador LIU Fei. They will all cherish this opportunity to have farming skills and introduce the

knowledge to anyone who are willing to start family farming.

Accompanied by the Chinese technicians, the guests toured the nurseries and the green house. All of them were amazed by the cucumbers, tomatoes and capsicums in green house and the big watermelons in the fields. They asked questions about farming skills and got satisfactory answers from the Chinese technicians. Officials of all the women organizations were confident that the fruitful visit in the Pilot Farm was bound to bear a fruitful harvest in their home fields and would organize their members to visit the farm soon.

## Seen Any Good Movies Lately?

### *Spirited Away (2001)*

Two worlds collide when an unsuspecting family stumbles upon a gateway dividing our world from the spirit realm in Hayao Miyazaki's 2001 animated masterpiece, "Spirited Away." "Spirited" follows the spellbinding story of Chihiro, a sullen 10-year-old girl, as she struggles to survive a world of witches, gods, monsters, and spirits in order to rescue her parents from becoming trapped in the spirit domain forever.

Created by the "Walt Disney" of Japanese anime, Hayao Miyazaki, and re-released in the U.S. by his admirers at Disney Pictures, the English-dubbed "Spirited Away" features the voice talents of Daveigh Chase (*Lilo & Stitch* 2002, *The Ring* 2002) as Chihiro, along with Michael Chiklis (*Fantastic Four* 2005, *The Commish* 1991) and Lauren Holly (*Dumb & Dumber* 1994, *Navy NCIS*) as Chihiro's parents, Suzanne Pleshette (*The Bob Newhart Show*) as Yubaba/Zeniba, and David Ogden Stiers (*M\*A\*S\*H\**, *Beauty & The Beast* 1991) as Kamaji.

Before watching "Spirited Away," I regarded the work of the legendary Hayao Miyazaki with a calm, composed respectfulness. After experiencing "Spirited," my admiration of Mr. Miyazaki turned into a veritable obsession. I've since hunted down other great movies from this master storyteller, like "Porco Rosso" (1992), "The Castle of Cagliostro" (1979), "Howl's Moving Castle" (2004), and "Castle in the Sky" (1986). In addition to being fraught with unforgettable characters and one-of-a-kind plots, Miyazaki's movies also manage to impact viewers with meaningful morals about society and the environment. "Spirited Away" is one of Miyazaki's most eloquently fabled creations, proven by its winning of an Oscar at the 2003 Academy Awards for Best Animated Feature.

"Spirited Away" is a classic film

that will continue to touch the hearts and imaginations of all who watch it. I highly recommend this memorable movie to both children and adults for an unparalleled, magical experience. This animation is rated PG for some scary moments.

### *Appleseed Saga: Ex Machina (2007)*

Set in 2133 A.D., "Appleseed Saga: Ex Machina" also known as "Appleseed Ex Machina," follows the story of a young E.S.W.A.T. soldier named Deunan Knute and her cyborg partner, Briareos Hecatichires, as they work to discover the connection between the mysterious terrorist attacks plaguing the futuristic, utopian city of Olympus.

Based on the Seishinsha comic book by Shirow Masamune and produced by John Woo, "Ex Machina" is a successful follow up of its prequel film, "Appleseed" (2004). Director Aramaki and his slew of skilled animators deftly utilize ingenious computer graphics, realistic camera movements, and an automated animation style to construct this phenomenal sci-fi adventure.

If you enjoy playing tactical video games and are looking for a fun, visually dazzling movie, "Appleseed Ex Machina" is right up your alley. If you can, I'd also advise that you see the first "Appleseed" before watching this sequel. Overall, this film is an action-packed must-see. Its opening scene alone gives me goose bumps every time I watch it.

"Ex Machina" is a phantasmagoria of breathtaking graphic art framed in a captivating story that never patronizes its audience. With jaw-dropping visuals and insane stunts, this spectacular anime will keep your eyes glued to the TV screen.

"Ex Machina" is rated PG-13 for action/violence and brief strong language, and is available on DVD, HD-DVD, and Blu-Ray.

*Sweeney Todd: The Demon*

### *Barber of Fleet Street (2007)*

After years of incarceration for a false charge, barber Benjamin Barker returns to London seeking vengeance as the tormented Sweeney Todd. Set in the 19<sup>th</sup> century, "Sweeney Todd: The Demon Barber of Fleet Street" is a macabre musical melodrama that follows the journey of the anti-hero Todd as he spirals into a misanthropic career as a demented serial killer.

"Sweeney" is a film adaptation of Stephen Sondheim's 1979 Broadway musical. At the helm is director Tim Burton, who's amassed a large following, including myself, by creating humorous gothic stories like "Beetlejuice" (1988) and "The Nightmare Before Christmas" (1993). In "Sweeney" Burton creates a ghastly work of art that remains true to the original musical. This dark comedy received a Golden Globe for Best Picture, Comedy, or Musical earlier this year, and was nominated for three Oscars at the 2008 Academy Awards, winning for Art Director.

Johnny Depp is magnificently malevolent as the demonic Todd, marking one of the best perfor-

mances of his eclectic career. For his riveting portrayal of Todd, Depp received a 2008 Golden Globe Award for Best Actor in a Comedy/Musical. Also mesmerizing is Helena Bonham Carter as the unscrupulous Mrs. Lovett. Alan Rickman (Professor Snape from "Harry Potter"), who's always brilliant at playing the bad guy, is positively lascivious as Judge Turpin. Timothy Spall (Wormtail/Peter Pettigrew from "Harry Potter") is disgustingly corrupt as Turpin's henchman Beadle Bamford. Also notable is Sacha Baron Cohen ("Borat" 2006) as the ludicrous faux-Italian barber, Signor Pirelli.

Even though I've been a fan of Burton and Depp longer than the sun has risen in the east; not to mention that I have seen Sondheim's musical, I was still rendered speechless by this gorgeously gory screen version of "Sweeney Todd". If you'd enjoy a morbid musical with superb performances, caustic lyrics and a scheming plot, "Sweeney Todd: The Demon Barber of Fleet Street" is an absolute must-rent at the video store.

This musical satire is rated R for graphic bloody violence.


of approximately four to five thousand meters and rope amounting to eight thousand meters was used in this first effort. Affixed to the rope was a 1.2 square meter concrete anchor. The location of the FAD is about 17 miles off Malakal at 07°05.900' North /134°36.590' East" said President Etpison.

FADs are used to attract ocean going pelagic fish such as marlin, tuna and mahi-mahi (dolphin fish). They usually consist of buoys or floats tethered to the ocean floor with concrete blocks. Over 300 species of fish aggregate around FADs in the open ocean around the world. Fish tend to move around the FADs in orbits of differing dimensions and are used by both recreational and commercial fisheries. Deployment in advance of the derby will allow time for algal growth that attract the big game fish for the derby competition. A \$10,000 prize for billfish weighing in at more than 500 pounds is this year's Grand Prize. This year's event will be held on May 17<sup>th</sup> and 18<sup>th</sup>.



## Dried Banana and Grated Taro for Home and Business Use

Exciting work on drying and preserving local foods is being carried out in Mand Community, Madolenihmw, as led by Mr. Kiped Albert, of Pohnpei Agriculture of the Office of Economic Affairs, supported by the Island Food Community of Pohnpei, College of Micronesia-FSM Cooperative Extension Services, Japanese Overseas Cooperation Volunteers and Mand Community members.

A workshop was held in the Mand Community Hall on 2 April 2008, with 42 participants. Ripe banana slices and grated giant swamp taro (mwahng) were prepared and placed in a solar dryer that was built locally by Capitol Fabricators (see photo). The grated taro was placed on a banana leaf as this works best for drying (better than using a metal pan). Mr. Albert dried the banana for five days and shared the dried ripe bananas on 6 April to the delight of Mand Community members.

Some thought that the bananas had been fried, but Mr. Albert said, "No, these bananas are not fried. They are dried. We have to get away from frying, which is not healthy."

In addition to the solar dryer, a charcoal dryer, was used for nighttime drying and rainy days. Mr. Albert found that one night in the charcoal dryer and two full sunny days of solar drying are sufficient to dry the ripe bananas. The length of time that the bananas can be kept safely depends on how dry they are. The dried taro can be

made into delicious soup.

The dried bananas are tasty snacks for children and the whole family. They are healthy and are from local foods. **They have no unhealthy ingredients added, such as fat, salt or sugar.**

Juices were made by blending ripe banana and sour fruits, including soursop (sei) and calamansi (karetik) with coconut juice for sweetening. Mr. Hiro Sawano demonstrated how to re-cycle beer bottles, removing the label, sterilizing in hot water, and using a bottle capper instrument to keep the bottles closed tightly, for use later, up to two weeks.

All products were made using local food crops and offer potential for small business enterprises. More information on these technologies can be obtained from Island Food Community of Pohnpei (tel. 320-3259), Pohnpei Agriculture (tel 320-2400), and COM-FSM CES (320-5731). Thanks are extended to the Global Environmental Facility Small Grant Program and New Zealand Embassy for the funds to support this workshop to Dr. Perera and Ione deBrum, consultants providing initial help, supported by the Secretariat of the Pacific Community Forests and Trees Program, and Kiped Albert and Kathay Larsen for assistance in writing this article.

### Dried Ripe Banana Slices

1. Select ripe raw eating bananas, preferably *Daiwang*, *Utin Pihsi*, and *Kaimana* (some varieties of banana give an itchy sensation, such as *Utimwas* and *Utin Iap* and should be cooked).
2. If the fruits are small, slice in half. If fruits are large, slice into more pieces.
3. Place on the solar dryer in the sun early in the morning on sunny days. Rotate dryer to keep in full sun. If it is rainy and little sun, place in charcoal dryer so that it can start drying right away. If the pieces are in the dryer without sun or charcoal drying, they will spoil.
4. Eat as a snack.
