# ‘Pacific Partnership’ to arrive in Pohnpei July 3

USS Cleveland carries multinational team of doctors, dentists and engineers

*Pohnpei, FSM*—A multinational team of doctors, dentists and engineers will arrive in the Federated States of Micronesia aboard the USS Cleveland (LPD 7) on July 3 for Pacific Partnership 2011.

An advance team of 25 U.S. Navy engineers from Navy Mobile Construction Battalion 133 based in Gulfport, Miss has been working hard in Pohnpei since

early June. The team has been working on engineering projects at Temwen, Wone, Palikir, Parem and Ohmine Elementary Schools, as well as Saladak Sports Facility. Those projects will be completed during the period of time that the USS Cleveland and its crew are on island July 3 – 15.

The Pacific Partnership 2011 medical team, which includes representatives from Australia, New Zealand, Japan, Canada, Singapore and the United States, as well as members of several non-government organizations, will arrive in

# Twenty FSM recruits inducted into the U.S. Armed Forces

*Pohnpei, FSM*--Twenty young FSM citizens stood with their heads high and their right hands held aloft today as they prepared to take the oath of enlistment to the U.S. Armed Forces. The audience of more than 70 people, many of them the friends and family members of the future soldiers, looked on attentively. Even children stopped their fidgeting.

As Captain Esteban Kemmey and staff sergeant Walter Asher administered the oath, each of the young men and women solemnly mouthed the words that will commit them to the service of the United States Military in the months and years to come.

“ I do solemnly swear that I will support and defend the Constitution of the United States against all enemies...”

The program for the oath of enlistment that was held at the US Embassy in Kolonia Pohnpei on June 23rd opened with an invocation by the Rev. Joseph Billoti and the piped in playing of the FSM and U.S. National Anthems respectively. As a light rain began to fall, First Sergeant Albert Fagan offered the recruits and audience a few welcoming words.

Lori P. Dando, Charge’s d’Affaires of the US Embassy to the FSM made a short speech during which she acknowledged the challenges that the new recruits are sure to face in boot camp. Despite the coming adversity she told the recruits that she had faith in their success. Dando spoke of her father’s service during WWII in the Marshall Islands and of the long standing mutual relationship between the FSM and the United States.

Lorin Robert, Secretary of the FSM Department of Foreign Affairs also spoke. He congratulated the recruits and encouraged them and the members of the audience to visit and pay respect to the portraits of fallen soldiers of the FSM currently on display at the Pohnpei International airport. He said that rather than looking at those portraits as morbid tokens of the worst-case scenario he hoped that FSM citizens would take the same kind of pride that he feels toward the young men and women of the FSM who have made the ultimate sacrifice for the safety and security of the world.

# US and Japan agree to postpone Guam military buildup

**Pohnpei, FSM**—Eight years was too ambitious a goal for the relocation of the military base in Futenma, Okinawa, Japan and to also relocate approximately 8000 U.S. Marines from Okinawa to Guam. So said statements issued today by U.S. and Japanese representatives.

"Completion of the FRF (Futenma Replacement Facility) and the Marine relocation will not meet the previously targeted date of 2014," the two allies said in a statement following cabinet-level talks in Washington yesterday, an Aljezeera news article said today.

US Secretary of State Hillary Clinton and US Defense Secretary Robert Gates hosted their respective Japanese counterparts, Takeaki Matsumoto and Toshimi Kitazawa for Security Consultative Committee talks yesterday. It was the first 2+2 meeting between the allies in four years.

The two governments promised to complete the projects 'at the earliest possible date after 2014.'"

Today's announcement regarding U.S. troop realignments in Okinawa was not a treaty obligation between the allies.

Neither was the 2006 commitment but both

governments have made multi-billion dollar commitments toward the Okinawa troop realignments.

Meanwhile there are all manner of mixed messages from the U.S. about Okinawa troop realignments.

For Micronesian nations the most confusing messages center on the military buildup in Guam.

Some U.S. lawmakers are saying that troop realignment arrangements are "unrealistic, unworkable, and unaffordable."

A June 17 press release by the U.S. Senate Armed Forces Committee chaired by Senator Carl Levin, a Democrat from Michigan said that the Committee had completed its markup of the \$682.5 billion budget for national defense programs for Fiscal Year (FY) 2012. Left on the cutting room floor after the bi-partisan committee unanimously approved the bill on June 16 was all of the \$180 million that would have gone toward furthering the process of relocating some 8000 US Marines from Japan's Okinawa prefecture to Guam, potentially with their families.

The press release which summarized the committee's markup of the budget said that the committee placed a "prohibition on funds for the realignment of USMC forces from Okinawa to Guam until the Commandant of the Marine Corps provides an updated force lay-down. The Secretary of Defense must also submit a master plan to Congress detailing construction costs and schedule of all projects necessary to realize the Commandant's force lay-down..."

Senator Clair McCaskill a Democrat from Missouri, the "Show Me State," who chairs the Subcommittee on Readiness and Management Support made a strong statement during a hearing. "This subcommittee will not authorize such multibillion-dollar projects without showing the rigorous analysis behind why we are doing what we are doing and a well-thought-out master plan of how we are going to get it done at a set cost and on a set schedule."

McCaskill's statement came just a few days before Senator Judi Guthertz, Guam's military buildup committee chairperson received a letter from Assistant Secretary of the Navy Jackalyne Pfannenstiel.

According to an article by Therese Hart, Marianas Variety Chief Reporter, Pfannenstiel affirmed in her letter, the U.S. government commitment to the relocation of Marines from Okinawa to Guam. She wrote that the United States has received similar assurances from Japan, despite the devastating disasters there in recent months.

"The Department [of Navy] will continue to work with Congress to address their concerns and secure necessary funds to support construction on Guam."

"While we are committed to mitigating the impacts of the relocation, we must look for cost-effective ways to do so," Pfannenstiel stressed.

Guthertz told the Marianas Variety that Guam must "be patient and wait to see what happens."

She said, "The entire 3rd Marine Division and the 1st Marine Air Wing and its logistical component, more than 18,000 Marines, are currently based in Okinawa - together, perfectly located, from their point of view, in the heart of the Asian-Pacific region, and close to its amphibious ships in Sasebo, Japan. Why would the Commandant want to back away from the potential area of conflict, split his force, and start all over again developing training and exercise facilities? We must face the reality that our Marines are being pressured to reduce their presence on Okinawa."

"Japan is the nation that wants the redeployment to happen, not the United States. Therefore, our Senate may require the Marine Commandant to certify his 'preferred lay down of his forces in the Pacific.' His preferred lay down is to stay right where he is - in Okinawa. However, he will be under orders to move about half of his forces out of Okinawa," Guthertz told the Marianas Variety.

"Our Marines will not be going to the Philippines or to Australia or anywhere else but Guam. As our realtors are fond of saying, 'It's all about location, location, location.' I am confident that the Marine Commandant can produce the desired document, even though he will be perhaps pinching his nose while he does it," she added.

If the loudly reported voices of Guam's citizens over the last five years are to be believed, most Guamanians are either wary or vehemently opposed to the proposed buildup.

It seems that U.S. lawmakers have heard their voices loudly and clearly. But those voices may only actually represent a small but vocal portion of the residents of Guam.

# President Mori has called a Special Session of Congress

President Manny Mori, in a letter to Speaker Isaac V. Figir, dated June 10, 2011, has called for a twelve-day special session of Congress, to commence on July 25, 2011.

This will be the First Special Session of the 17th FSM Congress, which will take place after results of the special elections in Kosrae and Chuuk States have been certified by the FSM Election Commissioner, to fill vacant at-large seats vacated by President Manny Mori and Vice President Alik L. Alik when they were re-elected by Congress on May 11, 2011, to a second term.

The President indicated in his call for a special session that four (4) urgent issues should be considered by Congress including, nominations for Cabinet Members and Ambassadors, proposed fiscal year 2012 budget, fiscal year 2011 supplemental budget, and the budget for the Program Management Unit, Department of Transportation, Communication, and Infrastructure.

The Congress had started its review of the proposed fiscal year 2012 budget for most departments and offices of the FSM National Government at its First Regular Session last May.

The special session will precede the 16th Micronesian Chief Executives'

Summit which is scheduled from July 27-28, and which will be co-hosted by the National Government and Pohnpei State, and the Micronesian Presidential Summit which will be held the afternoon of July 28. The Congress will recess for the Inauguration Ceremony which is scheduled on July 29 at the China-FSM Friendship Indoor Auditorium in Palikir.

# World Blood Donor Day 2011

On June 14th, the Micronesia Red Cross Society, Pohnpei Health Services, and the National Department of Health and Social Affairs celebrated World Blood Donor Day in the State of Pohnpei. Temporary blood typing clinics and information stations were set-up outside FSM Telecom, Palm Terrace, and the Department of Health in Palikir to give people the opportunity to find out their blood types, learn more about blood donation, and become registered voluntary, non-remunerated blood donors. A similar event is planned for July in Chuuk with the assistance of the Chuuk Women's Council (CWC), which has enthusiastically taken on the task of assisting health services with donor recruitment.

World Blood Donor Day is held every year on June 14. This date was chosen by the World Health Assembly because it is the birth date of Karl Landsteiner, the scientist who discovered the ABO blood group system. On or around this date, countries across the globe plan activities promoting a safe and adequate blood supply that is accessible to all patients who require transfusion.

Approximately 350 people came out to the World Blood Donor Day events on Pohnpei, and of these, 296 had a finger prick check of their blood group and 120 registered to become voluntary, non-remunerated blood donors.

The FSM blood donation mascot, Benny the Blood Drop, popped by to add some color and fun to the event. He proved a big hit with children and adults alike. Photos of Benny and some of his potential donor friends can be found on the FSM health website ([www.fsmhealth.fm](http://www.fsmhealth.fm)). Although the free t-shirts were in limited supply, our blood bank slogan "Sapankihda nta, iei, sapankihda mour" generated a lot of debate amongst the Pohnpeian language scholars in attendance.

Of the Pohnpei participants who had their blood group checked, 39.0% were group O positive, 32.0% were group A positive, 22.0% were B positive, and 7.0% were group AB positive. No Rh negative potential donors were found. Rh negative blood types are rare in the FSM, making donors difficult to find when needed. If you are Rh negative, and would like to be registered as a potential blood donor, please call 320-7077 (MRCS) or 320-8300 (DHSA).

The blood bank in the Pohnpei hospital will be keenly monitoring its statistics, eagerly anticipating an increase in volunteer donors in response to the blood donor recruitment activities.

## Blood Donation in the FSM

FSM is actively working towards a goal of 100.0% voluntary non-remunerated blood donations. The safest blood donors are voluntary, non-remunerated (unpaid) blood donors from low-risk populations. Greater than 80.0% of donors in the FSM, however, are family donors, which are associated with a significantly higher prevalence of transfusion-transmissible infections (TTIs), including HIV, hepatitis B, hepatitis C, and syphilis. Often family members are put under pressure to donate, and thus may not be willing to disclose any high risk behavior, or may be pressured into donating when they are not feeling fit and strong, or just after spending a quiet evening at a sakau bar. The practice of paying donors has been banned in the FSM and around the world, as paid donors, prisoners, and donors who have been coerced to donate have been found to have the highest rates of infectious disease that may be passed on to a patient receiving a transfusion.

Most people in the FSM have had the frantic experience of trying to find donors when family and friends require a blood transfusion. Patients requiring transfusions may have to wait an unacceptably long time for a transfusion, unless adequate stocks of blood are available in hospital blood banks at all times for any patients requiring transfusion.

Annually, hospitals in the FSM need

around 2,000 units of blood. If 3.0% of the population became volunteer blood donors, we could easily meet our transfusion needs.

Blood from donors can be stored in dedicated blood bank refrigerators for up to 5 weeks. If a bank of blood was available at all times, monitored by trained blood bank supervisors, then blood stocks could be managed better, and the need for emergency calls for donors would be significantly reduced.

Healthy individuals can donate up to 4 times a year; so even if people were willing to commit to donating 2 times a year, FSM could meet its transfusion needs with around 500 dedicated donors.

## The Blood Donation Process

When you donate blood, approximately 470ml (about one pint) of blood is taken. There is enough blood in the body to donate this amount without experiencing any ill effects.

Your body will make new blood after each donation. Within 2-3 hours of donating, your body will have replaced the fluid lost in the donation, especially if you drink plenty of water or juice before and after donating. Red blood cells are replaced with 3-4 days, especially if you eat iron-rich foods, such as lean red meat and dark green leafy vegetables. White blood cells are generally replaced by your body within about 3 weeks of donating.

All blood is collected according to standard operating procedures recommended by the International Society for Blood Transfusion, including the use of sterile, single-use needles and blood bags. Blood donations are screened for hepatitis B, hepatitis C, HIV, and syphilis. Even with this screening, some infections that can be

transmitted through a blood transfusion might be missed, which is why all donors are interviewed as well. You will be asked a lot of health-related questions; some of these will be rather personal and may be embarrassing, but they are necessary to ensure the safest blood supply possible.

Before donating, you will also be given a mini health check. Your blood pressure and pulse will be taken, along with a check of your hemoglobin, to ensure that you can safely tolerate the donation.

So, when you are feeling fit and well and want to share your good health with your fellow community members, why not call your state hospital blood bank, and make an appointment to donate blood?

Pohnpei July 3 aboard USS Cleveland (LPD 9), the flag ship for the mission.

Medical and dental services will be provided free of charge from 9 a.m. until 4 p.m. at the Chuuk State Hospital from July 5 to 7, and in Pohnpei at Nanpei Memorial High School from July 6 to 9, Lukop Elementary School from July 11 to 13 and Pohnpei State Hospital from July 12 to 13. A wide variety of out-patient, non-surgical services will be offered on a first-come, first-serve basis to anyone of any age. Those in urgent need of care will be identified and seen as soon as possible.

In addition to the medical, engineering and community services that will be conducted throughout the mission in FSM, there will also be several ceremonial, sports and music events that will be open to the public and free of charge.

On Monday, July 4, at 10 a.m., there will be an opening ceremony for the Pacific Partnership 2011 mission in FSM at the Pohnpei State Administration Complex. At 2 p.m., the USS Cleveland softball team will compete against the Madolenihmw team, then LPG team at the Spanish Wall softball field. At 5 p.m., the Pacific Partnership band will team with local musicians to host a music concert, also at the Spanish Wall.

On July 5, 11 and 12, at 5:30 p.m., the USS Cleveland soccer team will play local teams at the Pohnpei Track and Field Facility.

On July 6, 7 and 8, at 5 p.m., the USS Cleveland basketball team will compete against local teams at the College of Micronesia Gymnasium.

On Friday, July 8, at 12 p.m., there will be a ribbon cutting ceremony at the Ohmine Elementary School to celebrate the completion of the Pacific Partnership construction project at the school.

On July 9 and 10, at 3 p.m., the USS Cleveland softball team will compete against the team from Nett at the Spanish Wall softball field.

On Sunday, July 10, at 3 p.m., following the softball game, the Pacific Partnership band will team with local musicians to host a music concert from 5 p.m. until 7 p.m., also at the Spanish Wall.

On Tuesday, July 12, at 1 p.m., there will be a ribbon cutting ceremony at the Wone Elementary School to celebrate the completion of the Pacific Partnership construction project at the school.

On Wednesday, July 13, at 1 p.m., there will be a ribbon cutting ceremony at the Temwen Elementary School to celebrate the completion of the Pacific Partnership construction project at the school.

Lastly, on Thursday July 14, the closing ceremony for the Pacific Partnership 2011 mission in FSM will be held at the Pohnpei State Administration Complex.

Now in its sixth year, Pacific Partnership 2011 is aimed at strengthening regional

relationships with Southeast Asian and Oceania nations that might be called upon to respond to natural or humanitarian disasters in the region. Pacific Partnership is designed to enhance these relationships through medical, dental and engineering projects, as well as subject matter expert exchanges (SMEEs).

This year's mission began on March 21 and has already visited Tonga, Vanuatu, Papua New Guinea and Timor Leste.

"Since the 2004 Tsunami that caused profound suffering in several South East Asian countries, we have learned that by working together we are better prepared to overcome the considerable challenges caused by natural disasters," said U.S. Navy Capt. Jesse Wilson, Pacific Partnership 2011 Mission Commander, and Commander of Destroyer Squadron Twenty Three.

The amphibious transport dock ship USS Cleveland (LPD-7) is the lead U.S. vessel. Ships from Australia, Japan, and New Zealand, and a helicopter crew from France, will join the USS Cleveland during different phases of the mission though not during the FSM mission. Canada, Singapore, and Spain will also deploy teams to support the mission.

Non-governmental organizations (NGOs) will embark on the USS Cleveland to partner with its multinational crew to provide medical, dental, veterinary, and engineering services to local communities identified by host nations.

In addition to medical and engineering infrastructure projects, partner nations and NGOs will work with their host nation counterparts on developing sustainability projects and SMEEs on a range of topics, including methods of recycling, clean water practices, and alternative energy initiatives.

"Our goal is to build sustainable partnerships and projects that will strengthen alliances while working to prevent or mitigate humanitarian disasters," said Capt. Wilson."

Over the past five years, Pacific Partnership has provided medical, dental, educational, and preventive medicine services to more than 300,000 patients in 13 countries. More than 130 engineering projects in more than a dozen countries have included school refurbishment and construction of entirely new clinics for providing essential medical services to remote villages and communities.

Lt. Zachary Harrell, Pacific Partnership 2011 Public Affairs Officer said that the USS Cleveland which carries approximately 700 people aboard is too large to dock at the Pohnpei Port Authority dock. He said during a media coordination meeting that while that fact creates some logistical problems in terms of shore leave time for members of the mission to visit local sites and businesses, efforts will be made for some crew members to be able to enjoy Pohnpei and perhaps to stimulate the local economy on a small scale.

## ...Guam buildup

A survey commissioned by Para Hita Todu ("For All of Us" in the Chamorro language) and conducted by Market Research and Development, Incorporated says that only 16 percent of Guamanians oppose the military buildup, according to the Marianas Variety.

MV's article says that 60 percent of local residents "support the military alignment and the related development associated with the buildup."

It's possible that 24 percent of the population is simply wary. The survey showed that percentage of the population "could not decide one way or the other how they feel about the buildup."

The article said that the three top stated reasons among those 16 percent of local residents who do not support the buildup were feelings that the buildup would hurt the local culture, that the buildup would bring too many outsiders, and that the promised benefits would not happen.

The 60 percent segment of Guam residents who supported the buildup in Guam said that they felt it would create jobs, improve the economy today and into the future and would generate tax revenues for the government.

"While most of those opposed to the buildup are Chamorro (11%), there are 2.5 times as many Chamorro residents in favor of the buildup (26 percent)," the Marianas Variety article said.

Para Hita Todu is a newly formed community development corporation with a mission to embrace the opportunities from the military buildup. It consists of several local mayors, businessmen and other community leaders. Dededo Mayor Melissa Savares is the chairperson for the organization and represents about 40,000 Guam residents.

The relocation of Marines and potentially their families to Guam looms large on the horizon of economic hopes for Guam's neighboring Micronesian island nations whose citizens have been hoping for the possibility of economic spillover from the promised military buildup in Guam.

Lorin Robert, Secretary for Foreign Affairs for the Federated States of Micronesia said that FSM President "Manny" Mori has gone on record many times in Guam and in Washington D.C. saying that the FSM supports the relocation of 8000 U.S. Marines from Okinawa to Guam for many reasons including increased security in the Asia Pacific region.

"Some of our citizens have already benefited from the anticipated buildup in Guam," Robert said. "Some of them have taken part in vocational training in Guam through the Center for Micronesia Empowerment."

Some of those citizens have returned to the FSM workforce and others have found gainful employment in Guam after their training by the non-profit organization.

Robert said that there is some hope for the future that soldiers and their families stationed in Guam might use at least some of their leave time to visit the beautiful tropical islands of the FSM, particularly those most easily accessed from Guam.

A steady flow of tourists would stimulate the FSM's lackluster economy.

The U.S. Senate Armed Forces Committee's denial of budget for the planned military buildup in the 2012 budget is by no means the final word on the matter. The full Senate has yet to vote on the committee recommendation.

The U.S. House of Representatives has already done so. That body's version of the National Defense Authorization Act (NDAA) for Fiscal Year (FY) 2012 includes funding for the military buildup in Guam.

Since there are discrepancies between the versions of the bill between the two bodies a joint Senate and House conference committee will need to be called before a final version of the 2012 NDAA emerges from Congress.

President Obama would then need to sign the finalized bill into law, veto it or let it pass into law without his signature. If he were to veto the bill the combined houses of Congress could overturn a Presidential veto.

For now, the most encouraging words on Guam's troop relocation are coming from representatives of the Executive Branch.

Secretary Gates said during a post 2+2 press conference, "Secretary Clinton and I both informed our colleagues this morning that the letter from Senators Webb and Levin about the realignment is really a manifestation of growing congressional impatience with the lack of progress. We both reaffirmed the U.S. Government's commitment to the 2006 realignment plan, but at the same time emphasized the importance of concrete progress over the course of the next year."

## Police review update

21 June 2011

Chief of Police for Pohnpei State, Mr. Joe Roby has announced that the consultation phase of a Performance Review into the Pohnpei State Police has been completed.

The review was commissioned by the Director of the Department of Public Safety Mr. Lucas Carlos and Chief of Police Joe Roby and is being assisted by members of the Australian Federal Police, Pacific Police Development Program (PPDP).

The review is designed to assist in setting a stable course for the future of the police as they move towards preparing their strategic plans and goals for the future.

The consultation process involved three teams, made up of three Pohnpei State police officers and three officers from the PPDP. Interviews have been conducted with input from a wide cross section of the community.

The information gathered during the consultation phase will now be analyzed and the outcomes and recommendations

will be developed into the final Review Report. It is expected that the report will be available for dissemination to Government and interested stakeholders by the end of July.

Chief Roby has expressed his gratitude to the community for their input to the review.

"I am grateful for the input by the community. The review team spoke to a large number of people and community groups. Their input was very valuable and without it the review would not have been possible.

"It is too early to predict the outcomes of the report but I am certainly looking forward to it so we in the police will have a clearer picture of what areas will need addressing" Chief Roby said.

Chief Roby also thanked the PPDP for their ongoing support through funding a new supply of uniform items and police notebooks. It is assistance like this that helps us make those necessary improvements in our organization Chief Roby said.

- Boat Weight (90lbs) caught by the crew of Hunter, skippered by Jula Porter, winning 25 gallons of gas.



## Letter to the Editor

### Clarifications on the Chuuk road project

Dear Editor:

I should start off by thanking you for your continued effort to help provide information to the public through the Kaselehlie Press.

I would like to comment briefly on your article about the road project in Chuuk. I find it interesting that you sort of pedaled around the issue of the road's quality and project progress. I suspect we are both talking about the same stretch of road which leads from the airport area to the area next to the former Chuuk Legislature building.

That stretch of road is not "a bit narrow" as you put it. It is much too narrow for a main street where you can expect a tractor-trailer and a fire truck to pass each other safely without one having to climb onto the sidewalk. You may consider my choice of equipment using that road at the same time too extreme, but such extreme circumstances are what we should worry about before accepting the road design.

One other point I would like to raise concerns you assertion that the road is funded by the US Government.

The treaty between the United States and the Federated States of Micronesia lists no specific improvement projects and programs. This is unlike specific projects such as the Pohnpei Airport Extension from the Japanese Government, or the Pohnpei State Administration building in Kolonia from China for which particular requests were submitted to those governments for consideration under their overseas development assistance grants.

Funding for CIP projects in the FSM no on-going and those to come for the next 15 years are from committed money agreed to between the FSM and the United States under the Amended Compact, a treaty first entered into between the FSM and the United States in 1986. In return for such funding for improvements in the FSM, the FSM granted to the United States an indefinite military denial on a "this for that" basis.

## Center for Micronesian Empowerment provides more training

According to recent information from the Center for Micronesian Empowerment (CME) in Guam, ten trainees from Pohnpei are currently enrolled in a 90-day boot camp, which centers around construction training classes at the Guam Contractors Association Trades Academy. In addition, CME has reported that the State of Chuuk has announced it will send 12 trainees to Guam sometime in June to begin a 4-month intensive training course in "Mechanics" (Automotive Technology).

The trainings under CME's watch are part of a cooperative program between various State's Departments of Education in the FSM, the Center for Micronesian Empowerment (CME) and the GCA Trades Academy.

Mike Ghiglione, Executive Director

of the Center for Micronesian Empowerment, stated: "We are pleased with the success of our Micronesian trainees - they are proving every day that they are good, dependable workers."

Trainees from Chuuk have just completed their initial construction training courses. Of the 33 who successfully passed through their training, 30 are now fully employed in Guam, with many hoping to eventually return home to work there.

CME is now working to finalize arrangements for a 90-day "Certified Nursing Assistant" (CNA) program - with hopes to begin the program from October in cooperation with Guam Community College.

"There is a shortage of trained mechanics and nurses' aides on Guam and in the region and we hope these training programs for young Micronesians will address this shortage," Director Ghiglione expressed.

# Karat and Akadahh were at the 14th annual FSM Olympic Day walk/run held in Pohnpei

On Saturday, June 11th, the 14th the annual FSM Olympic Day walk/run was held in, Kolonia, Pohnpei, starting at Palm Terrace parking lot, sponsored by the FSM National Olympic Committee (NOC). Over 150 participants attended this activity. All participants got a T-shirt before they started and wore it while they ran/walked, showing support for the Olympic athletes training program. Participants started walking or running at 7am for 5 km through Kolonia town. The five dollar registration fee went towards costs of the Olympic athletes training for London Olympic.

The FSM Olympic Day walk/run was also held on the other FSM islands of Yap, Chuuk and Kosrae on July 18, 2011.

Before the run/walk started, a local food educator from the Island Food Community of Pohnpei (IFCP) gave the

IFCP standard talk, which includes the fact that one in three Pohnpeians are suffering from diabetes. Eating local food and exercising helps Pohnpeians stay away from non-communicable diseases (NCDs) such as diabetes, cancer and heart disease.

At the event, two varieties of bananas (Karat and Akadahh) were provided by IFCP for participants to grab before and after the run/walk.

Running or walking 5 km sounds a long distance, but doing it with your family or friends makes it such a fun activity.

The next fun run/walk is coming up on Saturday, July 9th, 2011: Let's Go Local Fun Run/Walk sponsored by the Island Food Community of Pohnpei with support by the FSM NOC.

# GO LOCAL participates in the Health Fair at the State Government building

MAHI International conducted a Health Fair on Wednesday, June 15th, 2011 at the State Government building. About 623 people attended the fair and learned about health issues, basic cardiopulmonary resuscitation (CPR) and more.

The Island Food Community of Pohnpei (IFCP) participated in the event, promoting "Going Local" and encouraging the community to grow and eat more local crops.

IFCP red pens were given to participants along with its message that one in three Pohnpeians are suffering from diabetes. The "Let's Go Local" message on the pen tells that making our life and eating style more local is an important solution to a health crisis in Pohnpei.

At the fair, yellow-fleshed bananas, Karat and Akadahh, were provided for participants to taste and enjoy, as well as providing a discussion point for the important values of yellow-fleshed banana varieties. A nurse from MAHI International who tried Akadahh for the first time said that it was

the best banana she had ever eaten and asked where she could buy it.

The IFCP Beta-carotene Food Charts (BFC) were also passed out to participants. The BFC indicates and compares the amount of beta-carotene in the local food as well as rice. Utin lap, a yellow-fleshed banana, contains 8508µg (microgram which is a weight measurement) of beta-carotene per 100 grams of banana (this is about half a cup).

One yellow-fleshed variety of giant swamp taro, Mwahng Tekatek Weitahta, has 4486µg per 100 grams.

Rice, which is frequently eaten among the Pohnpeian household, contains no beta-carotene, ZERO.

Beta-carotene is a pro-vitamin A carotenoid, which means beta-carotene becomes vitamin A inside of your body. Pro-vitamin A carotenoid is the only carotenoid that protects against vitamin A deficiency, which is prevalent among young children in Pohnpei (about 50% of the children in Pohnpei were vitamin A deficient).

Untreated lack of vitamin A could lead to vulnerability to infection and also night blindness or total blindness. Skin disorders, infections, diarrhea and respiratory disorders can also be the result of vitamin A deficiency. Carotenoid rich food, that is foods containing all the many different carotenoids, including beta-carotene but also other carotenoids like lutein, help protect against diabetes, heart disease, certain cancers and anemia (weak blood).

The Beta-carotene Food Chart is a great tool to teach the nutritional value of local foods to the community. One visitor came to our booth and said, "I know that local food is good but I never knew before the amounts of nutrients they contained and that they are so high, and this really impresses me."
