The competition was held amongst Pingelapese who reside in Pohnpei from each of the four groups (pwekil) on Pingelap Island, namely PwekilMweniap/Pasik, PwekilPeruku/Namahl, PwekilSakarekapw/Ihlong, and PwekilKakahlia/Pelenekeus.

College of Micronesia-FSM receives \$100,000 donation from the Tan Siu Lin Foundation

At a handover ceremony at the FSM President's Office, Mr. Kasio E. Mida, Chairman of the College of Micronesia-FSM Board of Regents, and the COM-FSM Acting President Joseph Habuchmai represented the college in receiving a \$100,000 donation from the Tan Siu Lin Foundation.

The donation was formally announced during the occasion of the trip by Federated States of Micronesia President Manny Mori to Hong Kong last month, during which the President also availed time to meet with the FSM Honorary Consul in Hong Kong, Dr. Tan Siu Lin. Dr. Tan is the founder and chairman of the foundation.

Before giving the check to the college representatives, President Mori commented on the usefulness of this kind of support that compliments the FSM's long-term priority for post-secondary education. He also acknowledged the work done by Ambassador Akilino H. Susaia, FSM Ambassador to China, which expedited the processes to bring in this specific donation.

On behalf of the COM-FSM community, Mr. Mida thanked President Mori and conveyed the college's appreciation for his strong support over the years. He also remarked, "the gift from the Tan Sui Lin Foundation is greatly appreciated and welcome, and we will make sure the college will make good use of it to strengthen its programs for and services to our students".

COM-FSM Acting President Habuchmai joined Mr. Mida in highlighting the college's gratitude toward the Tan Siu Lin Foundation and thanked the FSM Government for its part in securing the assistance.

To protect supporters' confidence in COM-FSM, President Mori encouraged the college to put in place a particular system for the acceptance of assistance such as this in a manner that mutually addresses the good intentions of the donor and the prioritized needs of the college.

Present with President Mori were Secretary of Foreign Affairs Lorin Robert, Ambassador Susaia and Chief of Staff Leo Falcam Jr.

Japan provides approximately \$1.9 million non-project grant for FSM

Embassy of Japan

On December 26, 2013, the Government of Japan and the FSM Government held a signing ceremony at the FSM Department of Foreign Affairs for the Exchange of Notes for a Non-Project Grant Aid for the Provisions of Industrial Products. This is the second signing ceremony for the Exchange of Notes this year following the Project for the Improvement of Domestic Shipping Services granted to the FSM in August of this year. This project in the amount of two hundred million Japanese Yen will be utilized to purchase the industrial products manufactured by the disaster affected areas caused by the Great East Japan Earthquake that struck Japan in 2011. This Non-Project Grant is intended to support and facilitate the FSM's efforts to improve its infrastructure and persevere towards boosting its economy. This ceremony marks the third Non-Project

Grant Aid the FSM government receives from Japan.

In his remarks, Ambassador Suzuki highlighted on the fact that this ceremony is unique as it marks the first-ever second Exchange of Notes within one-year. This event itself, he said, speaks of the continued fortification of the ties between the two governments.

On the receiving end, FSM Foreign Affairs Secretary Lorin Robert thanked the Government of Japan for their continuous support and friendship with the FSM and remarked that this signing ceremony is special as it resembles a continuation of the Holiday season with the receiving of the grant.

The Exchange of Notes took place at the Department of Foreign Affairs conference room with the attendance of The Honorable Lorin Robert, Japan Ambassador to the FSM Eiichi Suzuki, and staffs from Department of Foreign Affairs and Embassy of Japan.

Citizen calls for account of Madolenihmw public projects

Pohnpei, FSM—As the result of a phone call from a concerned citizen of Madolenihmw and following interviews with municipal government officials, Pohnpei's Office of the Public Auditor conducted a review on the administration and accountability of public funds in Madolenihmw. The review was limited in scope and covered only the \$105,000 that was allocated for community projects funds during fiscal years 2010 through 2012. That amount was approximately 10 percent of total municipal government budget during fiscal years under review.

As a result of the review, Pohnpei's OPA released a three page management report to communicate their findings and conclusion to management and appropriate government officials. The letter was copied to Governor John Ehsa, Speaker Peter Lohn, Meninkeder Lapalap, and the members of Menintiensapw.

The letter says that the \$105,000 was divided equally among the seven major sections in the municipality. The Councilmen representing each section (lopidi) were the designated allottees of the project funds. Check disbursements, accounting and reporting were the responsibility of the executive branch.

The Management Letter listed three principal findings of the review.

Under the first finding, "Lack of Project Plan", the management letter said that there were no project plans for most of the community projects that would justify the expenditures made to implement them. It said that most of the community projects and programs were selected and implemented at the discretion of the Councilmen.

The second finding said the projects suffered from "weak project administration, monitoring and reporting". It said that funds were appropriated in one lump sum. Councilmen for each section selected projects or programs at their own discretion. "In most cases, funded projects were not properly documented, justified and monitored, making it difficult to track progress," on the projects. "Project reports were not prepared to ensure compliance with State laws.

The third and final finding was that there was non-compliance with the Pohnpei Financial Management Regulations.

"Disbursements of project and program funds were often processed based on requests made directly by the councilmen without proper justification."

Because of the mismanagement of the community projects, the Madolenihmw Municipal Government (MMG) cannot answer the basic expressed questions of its citizens such as:

- Who has legal custody over assets procured with project or program funds?
- What expenditures should be allowed and disallowed?
- Who has primary responsibility over assets purchased, including maintenance and protection?
- In the event of property sale, who has authority to keep and dispose the proceeds from the sale?

The auditors concluded that the MMG's practice related to public funds for community programs and projects "undermined the basic principles of government standard operations, in particular the separation of powers (amongst) the three branches of government."

They said that the lack of clear policy guidelines should be of concern to the government leadership and the people. "Unclear policy and compliance guidelines increase the risk for fraud, waste, abuse and mismanagement of public resources."

The management letter made four recommendations to strengthen and improve transparency and accountability of its community project and program funds, specifically:

1. Lawmakers should not be involved in the administration of the community project and program funds.
2. MMG should establish suitable and clear policy guidelines governing project funds, and guidelines should include a requirement for the preparation and submission of project implementation and project progress report prior to disbursement of funds.
3. Management should ensure that project funds are spent strictly for the purposes intended and in compliance with applicable laws.
4. MMG should consider and adopt its project and program development plan to guide management in its administration of public project funds.

The Management Letter was signed by Ihlen K. Joseph, the State Public Auditor.

Pastor Edmund Kalau - A life dedicated to bringing hope and changing lives

Pacific Missionary Aviation

January 9, 2013

Guam—Pastor Edmund Kalau, founder and President Emeritus of Pacific Mission Aviation, died on January 8, 2013 in Guam. He was born on July 9, 1928.

He is survived by his beloved wife Elizabeth, children and their families: Esther and Peter Reichert, Heidi, Ben and Isla Wright, Christel and Nicole Reichert; Norbert and Sylvia Kalau, Nadya, Chelsea and Alexander; Dieter and Lori Kalau, Kristoff, Erich and Kimberlie.

“Ed was a great mentor for me and inspired me and a lot of people by his dedication to what he was sent to do here,” wrote Epel Ilon who serves as a deacon at Pohnpei’s Pacific Missionary Fellowship. “He became a good friend of Micronesia and will be greatly missed!”

Pastor Kalau’s journey to the man he became began in the most unlikely of places. He was born and raised in East Prussia, bordering Lithuania. At the age of 10 he joined the Hitler Youth Movement where he received an extensive and very successful atheistic indoctrination in Hitler’s Third Reich philosophy and future for Hitler’s Germany.

When Edmund was 14, he joined the Hitler Youth Flying Corps. There, he learned not only to fly gliders and advanced soaring planes, but also how to build them. Those who qualified could transfer at 16 years of age, to motor powered flight training for another 2 years. All of these happened while attending special High School for the Hitler Youth Leadership. At that time, Edmund was fully committed to Hitler and Germany’s cause.

Edmund’s father was a professional military man. He greatly encouraged his son by his devotion to the armed forces and strict Prussian military discipline. The Spartan up-bringing and his father’s special training helped him later to escape from the Russians, when he became a prisoner of war.

When he joined the Luftwaffe, German Air force, he already had 4 years of required training in meteorology, aerodynamics, and basic flying. After a short combat training, due to the fast advancement of Russian armies into Germany, he and many others were sent to the eastern front to repel the

Russians. Because of inexperience in combat flying many young pilots did not return.

In 1945, the war ended. Germany was in shambles, and so was the future for Ed Kalau. However, his Mother’s prayers wrought a miracle in 1947, when he turned from Atheism to Christ. A Russian, an enemy of his country, led him to accept Christ as Savior.

In 1950 Edmund entered a seminary to become a missionary. After four years of training he was chosen by the Mission Board to be sent to Micronesia, formerly a German colony.

In January 1956, Rev. Edmund Kalau and his wife Elisabeth started serving as missionaries in Palau and Yap (Micronesia). Rev. Kalau made numerous trips to the outer islands with the then Trust Territory-operated field trip ships. On nearly all trips, sick people were taken aboard to be transported to the district center hospitals, but because of the long distances and slowness of the ships, many patients died en route.

Witnessing this again and again, Rev. Kalau was troubled in his heart and mind that there was no better or more effective way to help the outer island people, especially with their medical needs. The idea of airborne help was envisioned.

Rev. Kalau personally raised funds in the U.S. and Germany and with another pilot, Maurice Pickard, ferried the first aircraft from the U.S. to Yap in July 1974. The Mission Society for which the Kalau’s worked for over 20 years did not share the vision of an expanded aviation program.

Knowing the needs of the people and how much help could be provided with an airplane, especially in critical medical situations, and more importantly, knowing that this was what God had called them to do, the Kalau’s opted to leave the Mission Society and obey God’s direction in their lives. With three teenage children in school in the Philippines and no support, it was not easy. However, God was good in providing some faithful friends in Germany and the U.S. who came up with a modest support for them along with some extra funds for aircraft maintenance and fuel.


In 1975, Pacific Missionary Aviation (PMA) (DBA Pacific Mission Aviation)

was incorporated in Guam. With the same burden for the salvation of people in the Philippines, Flying Medical Samaritans (FMS) PMA was incorporated in 1982 in the Philippines. In 2008, Flying Medical Samaritans’ name was changed to Pacific Missionary Aviation, Philippines, Inc.

God gave a greater vision to Ed Kalau. Medical missionary vessels were put into service in Micronesia, Medical Ship MV Sea Haven and the Philippines, M/L Samaritan to reach those atolls and islands with no airstrip. Church planting, support and evangelism intensified, especially in areas where once the doors were closed, but now open because of the committed services of PMA. A Maritime & Fisheries Academy with a campus ministry was established in 1989 in conjunction with the Yap State Government. In 1998, PMA turned over the responsibility of the Academy to the National Government. PMA has also established youth centers, a printing shop, a television and broadcast studio and FM and SW radio station. In the Philippines an orphanage, learning centers, and dormitory facility with youth ministries were also established. These are witnesses to the ever present faithfulness and blessing of the Lord of the harvest and the faithful friends and supporters of PMA!

He was led to establish Pacific Mission Aviation (PMA) in 1975 and served as President until 1999. With the same mission and vision; PMA was established and incorporated in the Philippines in 1982.

After serving with PMA in Pohnpei for 25 years, Edmund and Elizabeth Kalau “retired” from active mission work in August 2004, and relocated to the island of Guam where he served as Senior Pastor to PMA’s mission church – Pacific Mission Fellowship. What was the secret of his energy and enthusiasm? Love for his Lord and love for the Island people.

About his “retirement”, Edmund said “Some think that it must be a great burden at my age to still minister and help where needed. This is not a burden – this is what I have been called to do, having been called out of darkness into His wonderful light. Until God in His time will send someone to take our place, Elizabeth and I will cheerfully serve and thank Him for such a privilege.”

While on Guam, Edmund continued his efforts in helping and assisting the community, local governments (FSM, Palau, Guam) in reaching out to the local Micronesian people who have made the island of Guam their home so that they would be productive citizens of the island of Guam.

Pastor Ed Kalau’s life was dedicated to bringing hope and changing lives to the people that he served. And by God’s grace, he continued to do so until the Lord took him home. He thanks the people of Micronesia for their love and friendship, and the opportunity to serve them!

culture. The organization's theme for 2013 was "Strengthening Collaboration and Understanding Brings Successful Results". As part of its efforts to promote its theme and preserve the Pingelapese custom, this year the PPOI conducted a canoe building project with assistance from local canoe building instructors from Pingelap Island. The local instructors worked directly with their respective pwekil throughout the whole project. The instructors were Jimmy Ehmes, Kensiro Boaz, Moden Boaz, Nickelson Mark, Nixon Boaz, and Oltrik Alex. The sacrifices and commitments made by these men were immeasurable because they had to be away from their families and homes for seven months. They provided the training for free. The invaluable project was targeted at any Pingelapese man who wanted to learn or refresh his knowledge and skills on the canoe building process. As a result of this project, there were a total of 6 new canoes that were built by the four groups.

To celebrate the important milestone in the organization's history, a canoe racing tournament was held amongst the four pwekil. The competition comprised four heats for men, four for women, and two heats for coeds (two men and two women on each canoe). The events took a whole day to complete and began with very important opening remarks by His Majesty Doahkesa Dr. Berysin Salomon, Wasalalalap Nanmwark of Pingelap. At

the end of the event, the total points for all of the races determined the winning team. Pwekil Sakarakapw/Ihlong (red team) took first place. Pwekil Peruku/Nemahl (blue team) came in second. The third place winning team was PwekilKakaliha/Pelenekeus (white team). Pwekil Mweniap/Pasik (yellow team) earned the fourth place.

At the closing ceremony, the speakers all agreed that the event was a great success.

2023 Planning Committee assesses FSM economy and long-term fiscal stability at 2nd meeting

Saipan, CNMI – The second meeting of the Federated States of Micronesia (FSM) 2023 Planning Committee was held in Saipan, Northern Marianas, on December 7-8 with the focus on creating long-term fiscal sustainability and evaluating feasible strategies in stimulating economic growth.

FSM President Manny Mori opened the meeting, noting the challenges facing the FSM economy with the expiry of financial assistance under the amended Compact of free Association with the United States in 2023.

The President also pointed to the need to sustain economic growth and emphasized the urgency for the strengthening of contributions to the Compact Trust Fund to ensure long-term fiscal sustainability and reduce the looming budgetary gap moving forward. Lack of action in addressing such shortfall at the present time will add more weight to the bleak financial burden that is foreseen to worsen at the start of fiscal year 2024.

The President further added that economic reforms, particularly revenue mobilisation and public administrative reforms, need to be immediately carried out to enhance and support economic growth strategies.

The State Governors from Chuuk, Pohnpei and Yap, and the Lt. Governor of Kosrae, concurred with the President's emphasis on far-reaching reforms and underscored the need to bolster fiscal stability and sustainability while growing the economy. The Leaders noted that for this to happen, clear and time-specific strategies and targets need to be designed and carefully executed with the greater involvement of private sector and development partners.

Updating the Committee on a number of on-going undertakings, the Secretary of the Department of Resource and Development (R&D) presented a progress overview on

sectoral reforms and noted that challenges continue to be significant due to limited support and capacity constraints.

The 2023 Planning Committee Secretariat, led by the Office of Statistics, Budget and Economic Management, Overseas Development Assistance and Compact Management (SBOC), with support from the Asian Development Bank and Pacific Islands Forum Secretariat, presented a long-term fiscal sustainability analysis and options for creating fiscal space to support the accumulation of funds for the Compact Trust Fund. The Office of SBOC also emphasized that significant efforts on fiscal front, along with political and leadership resolve are imperative to closing the expected shortfall in the Compact Trust Fund by 2023.

Additionally, with assistance from the FSM Development Bank Chief Executive Officer, the Leaders were also provided an appraisal on the business climate in the FSM and the challenges that are faced by investors and entrepreneurs. The business climate overview, with input from both the FSM Development Bank and the Department of R&D, was done with awareness of the existing rating on the "ease of doing business" in the FSM and the need to address the impacts of such assessment on business opportunities throughout the FSM.

The Committee agreed that the next meeting will be held in April/May 2014 with focus on:

- Progressing the work on Comprehensive Action Plan to be launched in the near future; and
- Finalize and prioritize (by timeframe) the proposed economic growth strategies in the four priority areas – Tourism, Agriculture, Fisheries and Energy – and other cross-cutting issues (such as infrastructure development and financing), in steady consultation with the Private Sector and relevant stakeholders.

I thought to use George Santayana's famous quote from 1905 in his book, "Life of Reason, Reason in Common Sense" and repeated by many famous people since then, but I find it a bit too cynical even for my taste. He wrote, "Those who cannot remember the past are condemned to repeat it." Certainly some of the news in 2013 should be memorable for that reason but sometimes things from the past SHOULD be repeated.

In 2013, the College of Micronesia made bold strides and regained its accreditation status, and held several commencement exercises for its successful graduates. Entrepreneurs began to look into new product lines such as coffee for potential export. Habele, the Cuthbert project and other donors including foreign embassies continue their philanthropic work in the islands. The message of the Island Food Community of Pohnpei to "go local" continues to be heard throughout the FSM. Several alternative energy projects were implemented in the FSM. Yvonne Neth, a Pohnpeian artist gained international attention. Doctors from all over the world visited the FSM to provide services that are otherwise not available. Some real progress has been made on climate change adaptability in the FSM. Onouh, Chuuk got a new library and a usable airstrip. The FSM Postal service ramped up

its ability to provide service in the FSM in a variety of ways including infrastructure and now the ability to track mail through the US Postal Service System. The International Organization for Migration continues its education program on human trafficking, and training for FSM emigrants who are considering a move to the United States. Swimming classes started. Women's groups were strong and rightfully getting stronger. The supposedly taboo subject of domestic violence began to be discussed in earnest. Trees were planted. Streets and neighborhoods were cleaned.

There were hundreds of good news stories in 2013.

There were of course, several stories to which Santayana's quote should rightly be applied--incidents that seem to happen over and over again.

Sometimes we need a little reminder of what has gone before, both the good and the bad.

Micronesian Chief Executives affirm solidarity: facing challenges and seizing opportunities as a region

The 19th Micronesian Chief Executives' Summit in Saipan ended on the 6th of December after three days of meeting. The six Governors and three Presidents from all the States, Territory, Commonwealth and National Governments in Micronesia discussed a range of issues with guidance from selected professionals, practitioners, academicians, leaders and high level staff members from within their various jurisdictions.

At the Summit, a total of fifteen (15) agenda items were presented to and discussed by the Leaders with input and guidance from several presenters. Among these items were:

Climate Change: Climate Change discussions highlighted the obvious fact that many of the islands in Micronesia are already being drastically affected by various impacts of climate change. This imminent experience explains why the Leaders agreed to continue exert efforts in climate change mitigation and adaptation.

Under the same subject, the Leaders congratulated Governor Eddie Baza Calvo of Guam for his appointment to the Presidential Commission on Preparing the US for effects of Climate Change. Governor Calvo was requested to assist other Micronesian entities in the context of this newly appointed role to "gain funding for appropriate adaptation projects". The Marshall Islands raised awareness of fellow Leaders to the existing Majuro Declaration on Climate Leadership endorsed by Pacific Islands Forum countries at the 44th Pacific Islands Forum in Majuro a few months back.

Micronesian Challenge: Considered a "success story" for the region, the Micronesian Challenge (MC) continues to garner the support of the Chief Executives in its expanded efforts, which now includes the development of the Micronesian Challenge Business Plan.

The MC presenters indicated that \$11 million is spent annually for the protection of more than 6,800 square kilometers of conservation reserves in the region. The MC hopes to achieve a total of 13,500 square kilometers of protected areas by 2020. The MC Business Plan "establishes a commitment to raise an additional \$42 million across the region" (\$7 million annually) to match projected costs for meeting the initiative's conservation targets.

Regional Health Insurance: The Chief Executives viewed components of a proposed regional healthcare plan that originates from the Association of Pacific Islands Legislators (APIL). Various indicated benefits of contributing to a region-wide healthcare plan were explored along with a recommendation for the need of a regional study to be conducted to better situate its potentials based on the experiences of current stand-alone plans in the MCES jurisdictions.

The Leaders expressed interest in the concept of a regional medical insurance plan and the prospects on the benefit of pooling resources for such plan.

Other Decisions

In a separate side-meeting, the Presidents of the FSM, the Marshall Islands and Palau agreed to extend the College of Micronesia Treaty, subject to legislative approval, to September 30, 2023 as recommended by the COM Board of Regents. "COM Land Grant federal programs are operated through the Treaty Among the Governments of the Republic of the Marshall Islands, the Federated States of Micronesia and the Republic of Palau Regarding College of Micronesia". At the latest status, the treaty was effective until September 30, 2013.

The Chief Executives held a separate session that involved officials from the US Department of the Interior that mostly concerned a report from the US Government on the impact of an estimated 56,000 citizens of the Freely Associated States residing in US jurisdictions. The Leaders had the opportunity to express their view on the report. The Governor of Guam "indicated his disappointment in the overall movement of the U.S. Government and the Department of Interior on issues of Compact Impact, especially the failure to develop a template for the measurement of impacts, failure to report in a timely fashion to the U.S. Congress and the failure to respond to overall health care, education, corrections and other impact issues". Other Leaders expressed concern regarding data compilation in the process for determining compact impacts.

The Leaders also touched on the issue of the status of the Micronesian Center for a Sustainable Future (MCSF), which is seen as a coordinating organ for the MCES. The DOI suspended a grant in February 2013 and support for the Center were put on hold.

As one of the last actions for the Summit, the Leaders agreed to improve the configuration of the MCSF to strengthen its secretariat function and be more responsive to the MCES.

Additionally, three resolutions also resulted from the Leaders' deliberations.

Resolution 19-01 pledges "expanded support of the Micronesian Chief Executives for existing regional, national and local initiatives to implement invasive species awareness, impact assessment and research, management and biosecurity programs and the continued support for the implementation of the Micronesian Biosecurity Plan".

Resolution 19-02 underscores the Chief Executives' recognition of and support toward the "social and economic development of the region through enhanced telecommunications capacity in the Republic of Palau and the Federated States of Micronesia".

Resolution 19-03 stresses the Chief Executives' "recognition of the accomplishments of Francis X. Solomon, an advisor of the Prior Service Program and the first director of the Technical Assistance Program at the Office of Insular Affairs and commemorating his death of August 22, 2013".

The Leaders also acknowledged the action taken by the Hawaii Invasive Species Council (HISC) which adopted a resolution in support of the development of the Micronesian Biosecurity Plan (MBP). A letter from the Leaders expressing appreciation for the State of Hawaii's supportive action was sent to Governor Neil Abercrombie with request for Hawaii's full participation in the development of the MBP and inclusion in the Micronesian Invasive Species Council as a non-voting member.

As a tribute to a departed Statesman, the Chief Executives took time to honor the passing away of President Nelson Mandela. A moment of silence was observed.

Before closing, the Leaders expressed their gratitude to the Government and people of the Commonwealth of the Northern Mariana Islands and announced that the 20th MCES will be held in Yap State in the Federated States of Micronesia. The specific date for the next meeting will be determined and announced by Yap State.

Background and function of Micronesian Shipping Commission

Micronesian Shipping Commission

Traditionally, commercial shipping within the former Trust Territory area was administered by the High Commissioner under Secretarial Order 2902, which allowed the provision of commercial shipping services by a single liner-carrier under a franchise agreement approved by the High Commissioner.

Because of the role of shipping in the administration of the TTPI, S.O. 2902 was designed primarily to induce commercial carrier operation in an area of low cargo volume and vast distances by providing the designated carrier with the necessary protection against competition and further dilution of the limited cargo volume available in the trade. However, by the mid-1970s, the volume of trade in the TTPI area had risen dramatically to a level where the single carrier concept and service could no longer accommodate the demand for reliable shipping.

Following the demise of TRANSPAC in 1974, the High Commissioner by virtue of Executive Order 113, established the "Entry Assurance System" to allow controlled competition in the provision of shipping service in the TTPI. Under this scheme a few selected carriers were allowed to provide liner service on specific routes to and from

the TTPI. The number of carriers authorized to service a particular route was determined by the volume of cargo moving in that trade route and the selection of carriers was based on the merits of proposals submitted by carriers in terms of frequency, rates, employment opportunities, financial background and investment in the TTPI ports. The operations of these selected carriers were reviewed annually to ensure compliance with their proposed service and in accordance with a set of criteria established under E.O. 113. Carriers that did not comply with the terms of their entry assurances were terminated forthwith.

With the establishment of constitutional governments in the FSM, Palau, and RMI in 1979, the responsibility over shipping and flag state matters did not change hand immediately. The FSM and RMI assumed these responsibilities upon affectivity of their compacts of free association, in the case of the FSM in 1986.

During the transition period prior to the transfer of these functions, the High Commissioner continued to regulate shipping and issue entry assurances; but the actual decisions affecting approval and disapproval were jointly made by the FSM, RMI, and Palau through the annual Micronesian Shipping Conference.

In 1984, during one such annual conference and in anticipation of the imminent turnover of these functions, the FSM, RMI, and Palau initialed an Agreement to continue to coordinate decisions affecting international shipping service. This was due in part to the interrelation of shipping routes within the three entities and the need for a united front in the negotiation of rates and other desirable service components; but most importantly the system had been proven to be the best in accommodating the desired quality and quantity of shipping service for the region.

In 1988, a revised Agreement was developed and signed by the representatives of the FSM, RMI, and Palau to the Micronesian Shipping Conference to form a "Micronesian Shipping Commission" to perpetuate regional consultation and cooperation on decision affecting international shipping service. The Agreement adopted in substance the criteria created under TTPI E.O. 113 as the basis for regulation of Entry Assurance for the three entities. The Republic of the Marshall Islands adopted the Agreement as an executive treaty, but the FSM and Palau failed to obtain congressional action to ratify the Agreement because of certain concerns.

In 1997, a final revised Agreement was developed to accommodate the concerns

of the participating governments and was signed by Secretary of Transportation and Communications (FSM), Minister of Transportation and Communications (RMI), and the Minister of Commerce and Trade (ROP) on behalf of their governments.

In spite of the non ratification of the Agreement, FSM, RMI, and Palau continued to meet annually as a matter of necessity to review and issue entry assurance under de facto Micronesian Shipping Commission from 1986 up to the Agreement's ratification on March 12, 1998 by the Legislative Body of the Government of RMI, November 25, 1998 by FSM congress and finally on September 16, 1999 by OEK, Republic of Palau.

During the period from 1986 and up to the dates the MSC Agreement was ratified by the three participating governments, the existence of the Micronesian Shipping Commission and its effectiveness in regulating international shipping was only possible because the carriers in the system fully supported the concept of the Entry Assurance.

The MSC meets annually to review carriers' performance and new proposal for shipping service to and from the region collectively called Micronesia sub-region

Second Oath of Allegiance ceremony in 2013: Carrie Lynn Boylan becomes FSM citizen

On December 17, Carrie Lynn Boylan became the second person in the history of the Federated States of Micronesia to obtain FSM citizenship through the new naturalization process when she renounced her US citizenship and received the Oath of Allegiance from President Manny Mori. Mrs. Boylan's father, Russel Jay Varner, is a US citizen and her mother, Rene'e Etscheit-Varner, a Pohnpeian from Nett Municipality, which made Mrs. Boylan a national of the FSM. Pursuant to a change in the law, FSM nationals may apply for and be granted citizenship under Presidential approval. Mrs. Boylan applied to become an FSM citizen by renouncing her US citizenship and applying for FSM citizenship through this new process. Aliens (those individuals who are not born or adopted to an FSM father or mother), need Congressional approval to become FSM citizens.

is born in another country or to a parent who is a citizen of another country, the child maintains citizenship in both countries until, within three years after reaching his or her 18th birthday, the child chooses which citizenship he or she wants to keep. If no election is made, then the child automatically becomes a national and loses his or her citizenship.

Mrs. Boylan was born in California, USA and moved to Pohnpei when she was less than two years old, where she grew up. She later went back to the USA to receive her education and after that came back and stayed in Pohnpei to date. Mrs. Boylan and her family have been engaged in the business commercial sector in Pohnpei State for more than 15 years. She is the operator and owner of Perfume and Things and is also the operator and owner of Varner Boylan Corporation, a real estate agency. Mrs. Boylan is married and has 4 children, 3 of whom were born in Pohnpei.

The FSM Constitution does not allow adults to hold dual citizenship, that is, a citizen of both the FSM and another country. However, when a child, who has at least one FSM citizen parent,


