

# FSM sells off sea cucumbers harvested by Vietnamese alleged immigration violators

**Pohnpei, FSM**—A substantial amount of sea cucumbers allegedly harvested by Vietnamese fishermen who were arrested for violation of immigration laws were put up for sale by the FSM Government.

FSM Secretary for the Department of Justice, **Jose Gallen** said that he authorized the sale. Information on the proceeds of the sale has been non-existent.

The FSM Public Defender who is defending the fishermen could not be reached for comment about the sale.

On July 4 the FSM Department of Justice

charged all of the men for violation of title 50 of the FSM code. Title 50 says, “It is unlawful for a person who is not a citizen of the FSM to unlawfully enter or attempt to enter the FSM without having been issued an appropriate entry permit.” The penalty for the charge is up to two years imprisonment and up to a \$10,000 fine.

All 33 fishermen are up on charges of that violation and some face two charges, one of whom was convicted and deported after a similar crime a year ago.

After the arrest, the Pohnpei State jail was bursting at the seams. The Vietnamese “fishermen” were released after one night and confined instead at the Dekehtik dock

# Lt. Governor Oliver donates 40 percent of his salary to uninsured medical patients

**Pohnpei, FSM**—True to the humble nature of the man, Lt. Governor **Reed Oliver** wasn’t there this morning when his wife and other family members presented \$10,000 of his annual salary of \$25,000 to the Pohnpei Department of Health. It’s 40 percent of his annual salary. He didn’t want the recognition. He still doesn’t, but such an example cannot simply be ignored and is not an example at all if only a few people know about it.

This morning the Lt. Governor’s family presented two checks, each in the amount of \$5000. \$5000 of the money is to be used for the cost of medicine for outpatients

# Guam's Attorney General would have advised Calvo to "proceed cautiously" on deportations

Guam—According to an article by Guam's Pacific Daily News, Guam's elected Attorney General Elizabeth Barrett-Anderson has raised concerns that Governor Eddie Calvo's actions to send three convicted migrants back to Chuuk could potentially raise "racial-bias" concerns.

PDN reports that she is putting together "legal guidelines for the agencies at the front line of the governor's actions, including the Department of Corrections and the local Customs and Quarantine Agency, to help them avoid potential civil-rights lawsuits.

She said that she wasn't consulted before the Governor signed the executive orders commutating the prisoners' sentences and using the word "deportation" in the text of the executive order.

"I would have said, Governor, proceed cautiously," Barrett-Anderson told the PDN.

According to a Question and Answer styled press release by the Governor's office, "At this point, removals are voluntary with the condition that the person never steps foot on Guam again...If a removed person returns, they could face serving the balance of their sentence at the point of commutation, or being sent home on the next flight out," the release said.

He claimed in his press release that his actions were a matter of Public Safety. "Those who are on Guam by virtue of visa or a treaty face the possibility of removal if they break Guam and U.S. laws."

The attorney general told PDN that in a

case appealed in the 9th Circuit Court, a trial judge's order for a convicted foreign criminal to depart and never return to the United States which would separate the inmate from his U.S.-based family was considered a form of judicial banishment of "draconian" proportions.

While the government of Guam is immune from civil-rights lawsuits, government officials and employees don't have the same legal shield, she told PDN.

She told PDN that she disagrees wholeheartedly with the Governor's claims that he has residual authority under the federal Organic Act to deport people.

She said that Governor Calvo quoted law from 64 years ago when the Federal Government appointed Guam's Governor.

On the other hand, Barrett-Anderson told PDN that the governor acted within his Organic Act authority to commute, or shorten the sentence of a convict, and to enter an agreement for that inmate to leave the island and never return.

In his Q&A press release, Governor Calvo said, "While public safety is the primary objective of this effort, there are economic benefits that cannot be ignored. The cost to house a non-U.S. citizen in Guam's prison system has been estimated by Department of Corrections officials \$119 a day or \$43,435 per year. This costs more than a one-way airline ticket; the most recent removals cost approximately \$400. DOC officials estimate that there are approximately 200 non-U.S. citizens in Guam's prison system. At this rate, Guam taxpayers are spending an estimated \$8.6 million per year housing non-U.S. citizen inmates. These public funds would be better spent improving the quality of life in the areas of public health, education and

public safety." Guam's AG told PDN that the local government must solve the inmate-crowding problem the right way, she said. "It has to be racially neutral," she said. Foreigners, including those who are called "illegal aliens," have constitutional rights to due process, which means they have the right to a deportation hearing before they can be deported, the attorney general told PDN. Calvo said in his Q&A press release that he has met with FSM officials who told him

that they are facing the same issue with foreign vessels illegally fishing in their waters. He claimed that FSM is dealing with those violators in the same way that Guam is dealing with FSM violators of their law—a one way ticket home.

It's a bit of an overstated representation of FSM's law enforcement problems for foreign violators of the law.

Calvo's press release says, "This process will continue as long as the safety of Guam's law-abiding U.S. and non-U.S. citizens are at risk and/or when the federal government begins prioritizing this matter."

## Kolonia Public Market space still a matter of controversy

Kolonia, Pohnpei—Alleged "squatters" have occupied the space where Kolonia Town has a lease for a public market, precluding its intended use.

Several years ago, the space was actually used as a public market but at some point, alleged squatters took residence and built on the land. There currently really is no "public" market in Pohnpei.

The Public Market in Kolonia, Pohnpei has been the hot seat of controversy for quite some time now, pitting Nett traditional leaders against Kolonia Town and Pohnpei State Government officials.

In response to numerous social media accusations that the Kolonia Town Mayor was "dragging his feet" on enforcement of the

lease on the public market space, we asked for an interview with Kolonia Town Mayor about the status of the Public Market.

What we got was a response from Jack Jack, Administrative Assistant saying that the Mayor had said that he could not comment on the matter other than to say that Pohnpei State has issued the lease for the site to the Kolonia Town government. Jack said that Mayor San Nicolas instructed him to tell us that Kolonia has a renovation plan for the site and that funding is in place for that plan but that Kolonia has filed suit against the State Government regarding the site.

Mr. Jack could not provide details on the contents of the civil action but said that he would ask an attorney to call us about that the details.

The phone call never came and a message to that attorney was not returned.

# Department of Education employee arrested

**Pohnpei, FSM**—On August 3 Pohnpei Police Officers arrested Mr. Penny Jimmy, an employee at the Department of Education on six counts of ethics violations, three counts of use of outside employment for self financial interest and a further three counts of use of state property or information for self financial interest.

The arrest is the result of an investigation led by the Office of the Governor, the Pohnpei Office of the Public Auditor, and the Department of Public Safety.

Investigators are also looking into potential additional charges of forgery and cheating.

The investigation alleges that as part of his official duties, Jimmy may have funneled

over \$400,000 dollars worth of Department of Education purchasing contracts for supplies into a company that he owns.

The DPS investigation is also looking into the possibility that other employees at the Department of Education were involved and may have benefited from the arrangement.

“This investigation is part of a new directive from the Governor to investigate and prosecute all reports of fraud and abuse within the Pohnpei State Government in a timely and active manner,” a source close to the Governor’s office explained. “This is the sort of activity that the Government of Pohnpei is no longer going to allow of its employees.”

Formal charges are expected to be filed by the Attorney General’s Office later in the month.

# Family of sea cucumber harvesters files suit against Nett and others

**Pohnpei, FSM**—A family with permits to harvest sea cucumbers has filed suit against “Public Safety”, Nett District Government, and “Nett District Government John Does 1 to 10” after the family was stopped, under threat of arrest from harvesting sea cucumbers in Nett waters on July 13.

They are asking the court to award them \$50,000 from each of the named defendants, \$150,000 in punitive damages, and “reasonable attorney’s fees”.

The plaintiffs are Joseph Edward, Nini Edward, AJ Edward, and Dott Edward.

The complaint (PCA 206-16) says that the “John Doe” defendants are sued under fictitious names because their true names and capacities are unknown to the plaintiffs but that after those names become known, plaintiff will amend the complaint to add their true names and capacities.

Each of the plaintiffs was issued a permit by the Pohnpei Office of Fisheries and Aquaculture under State Law 8L-58-14. The complaint alleges that they were thereby permitted to harvest certain designated species of sea cucumbers. Based on the permits, the plaintiffs “went to the Auresei Reef facing John Rasa’s place in Nanimwin Sapw Ipwal Section in Sokehs municipality at about 8:30 a.m., and began harvesting the designated sea cucumbers.”

# China provides funding for a Public Market in U—first outside of Kolonia

**U, Pohnpei**—Dignitaries from U, including His Majesty, the Nan Mwehrki and his wife, and the Iso Nahnken gathered on the grounds of the U Municipal government building to break ground on a dream that the Embassy of the People’s Republic of China has helped to make a reality.

Iso Nahnken Ihlen Joseph said that traditional leaders have been talking about establishing a public market in U for over 20 years but the problem has always been funding. That funding has now been provided and the Nan Mwehrki has donated the use of the perfect site on the grounds of the U Municipal Government.

Ms. Li Ciuying, Deputy Chief of Mission of the Embassy of the People’s Republic of China spoke of China’s long history of support in the FSM and the continued

friendly relations between the two nations.

Dahker Abraham, Chief Minister of U expressed his gratitude for the project. “I would like to assure you and your Government that this project will be a beneficial one for the population of U as well as all from the nearby residence of U,” he said, addressing DCM Li. “This project will really help minimize the cost of transportation and time for the Farmers and the Fishermen of the entire residence of U and Madolenihmw to run down to Kolonia for the exchange of their

products with the population of Kolonia Town.”

He said the project represents the first ever public market to be established outside of Kolonia Town.

He has already signed the contract for the construction of the public market with Contractor Paulus Kustin and has asked the people of U to give support and cooperation to the contractor

Lt. Governor Reed Oliver, Iso Nahnken Ihlen Joseph, Paulus Kustin, DCM Ms. Li, and the Nan Mwehrki of U turned the first shovels full of dirt over as the symbolic groundbreaking.

Reverend Henry Phillip gave the invocation for the ceremony. Speaker Estepan Primo gave opening remarks.

**Pohnpei, FSM**—Meeting with the theme “Fishing Together for a Pacific Free of Corruption and Poverty”, the 27th Annual Conference of the Association of Pacific Island Public Auditors (APIPA) kicked off at the College of Micronesia-FSM in Palikir. Hundreds of people from all over the Pacific were present for the opening day ceremonies where Deputy Inspector General of the U. S. Department of the Interior, Ms. Mary L. Kendall, delivered the Keynote Address.

The opening session began with the entrance of the Principals from each represented country and territory preceded by their flags.

Pohnpei’s Governor Marcelo Peterson welcomed the delegates to Pohnpei and to their conference.

A program for the week of the APIPA Conference was developed in collaboration with the Graduate School USA’s PITI-VITI Program and offered continuing education

for participants in four tracks: Audit, Audit Supervisory, Finance, and Accounting & Management.

# Special Session confirms Associate Justice and ratifies Climate Agreement, among others

**PALIKIR, POHNPEI. August 4, 2016** – The Fifth Special Session has adjourned sine-die on Wednesday - August 3, 2016, as scheduled, with the passage of numerous measures among which included the confirmation of an Associate Justice and the ratification of the Paris Agreement.

The Nineteenth Congress of the Federated States of Micronesia has confirmed Larry Wentworth to serve as an Associate Justice for the FSM Supreme Court. With a stellar background and over 20 years of service to the FSM Supreme Court, Wentworth’s nomination

was confirmed through the adoption of Congressional Resolution (CR) 19-236.

Another highlight of the concluded session was the adoption of CR 19-23 to ratify the climate change treaty better known as the Paris Agreement. The Paris Agreement is a treaty within the United Nation’s Framework Convention on Climate Change which calls for a global effort to reduce the emissions of green house gases in order to limit global warming to under 2°C. It also calls for voluntary goals or “nationally determined contributions” (NCDs), which would eventually become

binding. And finally the Paris Agreement calls for commitment by the developed countries to assist the developing countries in their efforts.

Congress also passed Congressional Act (CA) 19-101 to place a certain restriction on the newly created entity, “the Joint Committee on Compact Review and Planning.” During its session in May 2016, Congress had passed an Act (now Public Law 19-85) to create a Joint Committee on Compact Review and Planning to coordinate the Nation’s preparation efforts towards effective and smooth post Compact government in 2023. The newly passed Act

amends the new law to underscore that any contemplated or proposed negotiations with the US will be limited solely to Title Two - Financial Provisions.

In a similar vein, Congress had also during its May session passed an Act (now Public Law 19-90) to establish a National Scholarship Board comprising five members, one from the National Government and one from each of the four states. During the Special Session, the Body adopted the following resolution

who have no medical insurance or are not covered by some other medical policy "such as farmers, fishermen, small infants, youths, and "etc., etc....," the Lt. Governor wrote in an email that we received by accident.

He intends \$5000 of the money to go to help with off-island referrals from Pohnpei to the Philippines, "not for tickets as the amount is not big, but will be given in amounts that can help individuals and family members who are going to PI for medical referral to help cover other small expenses," his email said.

"Knowing the Dollar value versus the Peso, I believe that amount can help a bit," he wrote.

He said that he chose the 22nd of July to present his donation of part of his salary because it falls on his father's (Bermin Oliver) birthday. "Without him I couldn't be where I am today. He started all small things that have enabled me to go to school and (then to) come back and do the things I can do..."

The Lt. Governor's wife, Estelle Oliver presented the checks to his sisters who in turn presented the checks to Governor Marcelo Peterson, who then presented the checks to Acting Director of Health Services, Dr. John Hedson.

Lt. Governor Oliver's sense of stewardship is widely known. It is sometimes misunderstood.

Some members of the Legislature recently asked whether it is legal for the Lt. Governor to use his own personal vehicle while on official business. He doesn't use the official vehicle and says that he has provided his own fuel for his own personal vehicle even while on official business.

where they still reside.

According to FSM sources, Young Sun, was the buyer for all of the viable sea cucumbers that were aboard the vessels.

Young Sun is under a Temporary Restraining Order on their contract with Pohnpei State to manage a harvest of sea cucumbers in Pohnpei State waters. That restraining order did not restrict the company from buying allegedly ill gotten sea cucumbers from the FSM, obtained from the Vietnamese fishermen.

Anecdotal estimates of the sea cucumbers aboard the two vessels range from 10 to 20 thousand kilos.

# Sea Cucumber aquaculture project researches ways to make money from sustainable farming

**Pohnpei, FSM**—On July 20, at the height of the full moon, five female sea cucumbers rose up like cobras and spewed out over 10 million eggs at the carefully and scientifically controlled aquaculture facility at Nett Point. Of those, 49 percent hatched after male sea cucumbers fertilized the eggs—just over 5 million hatches. It will be a long journey before any of those sea cucumbers, the kinds that Pohnpeians eat, will be ready for market. The vast majority of them will die before they ever reach that stage, despite the carefully controlled environment.

The program is culturing “sand fish”, locally known as “langon”, and curry fish. Both are species that are locally consumed.

On several visits to the NIFA (National Institute of Food and Agriculture) and USDA (U.S. Department of Agriculture) sponsored Land Grant Program at Nett Point in Pohnpei, Dr. Manoj R. Nair shined a flash light into the spawning pools to show me the sea cucumbers growing there in the first stage of their growth process. “Look at where the light is shining”, he said. “You’ll see tiny little creatures on the bottom.”

Each time I smiled and nodded, but I have to admit that I was shining him on. I couldn’t see them unless they were the things that looked like tiny little grains of sand on the bottom of the tanks. He assured me that there were hundreds of thousands in each tank.

He said that stage of growth is about the time that some sea cucumber “farmers” dump the larva into the ocean and say that they have “farmed millions of sea cucumbers” to support their intended harvest.

But Dr. Nair says it’s much more complicated than making sure that eggs have been fertilized. They still have to survive and it would be hard for the tiny, almost invisible larva to do in the wild.

Sea cucumbers are ready for harvest at about 350 to 400 grams, approximately two years from the time that they are spawned. It’s no small investment in time.

In the controlled environment of the aquaculture lab, larva are fed only after experts have determined that they are ready, and then only on carefully monitored Spirulina covered plates. The water in the tanks is changed on a regular basis and the larva are moved from tank to tank as they progress in their development. In that controlled environment, less than 5% will make it as far as a sea cucumber farm. Even after that point, more will be lost before they are ready for harvest.

Dr. Nair said that sea cucumbers must be at least 30 grams in size before being released to farms. The “farms” are also carefully controlled environments and must be checked constantly. In each farm, approximately 90 tiny sea cucumbers each are placed into nine net bags per farm with holes only 900 microns in size. Farmers must constantly check for predators like crabs and get rid of them when they are found.

But crabs are not the only predators of sea cucumbers. Dr. Nair said that they found a perfect site in Sekere for a sea cucumber farm that had the required sandy sea bottom. Farmed sea cucumbers will not survive in sea bottom of rubble. He said it was the perfect place but they can’t use it any more. In 2014 they planted approximately 1000 sea cucumbers off the shore of Sekere. Every single one of those sea cucumbers were at harvest size.

They haven’t returned a farm to that site, but they

have several others. The program currently has a farm at Nihco Marine Park and hopes to have another soon. They have a farm at Mhawi Peisi island that requires daily monitoring by staff members to eliminate crab populations that encroach on the farm. There is another farm on an island off of Palikir. Currently there is one farm at Nett Point but on the date of our last visit, trainees were setting up another adjacent farm. Dr. Nair said they had negotiated another farm not far away in Pali Powe which also has good sandy bottom for sea cucumber cultivation.

There are still more predators. Climate change may well be one of them. Dr. Nair said that Pohnpei experienced unusually low tides after Tropical Storm Dolphin in 2015. The program lost every single one of the sea cucumbers in every one of its farms as a result of that climactic event.

It’s the goal of the program to try to find a way to make money from the farmed cultivation of sea cucumbers and other marine animals but Nair is quick to point out that the program is hampered by more than just environmental matters.

In some ways it has been hampered by political matters.

The much talked about “Sea Cucumber law” of 2014 allowed the Office of Fisheries and Aquaculture (OFA) to generate a set of regulations. In those regulations, OFA requires any person who is pursuing an aquaculture project to pay \$25,000 a year to a Fisheries Development Fund before operational taxes. Dr. Nair says that regulation essentially eliminates most people from investing in aquaculture.

“Who can afford to pay \$25,000 a year,” he exclaimed. “How can anyone make money if they have to pay \$25,000 every year before they’ve invested a cent?”

Legislators in Yap recently considered a bill

that would have required a 100% closure of sea cucumber harvesting. That law would have effectively closed the Land Grant Sea Cucumber aquaculture project there. Yap already has a law on the books that bans sea cucumber except during open seasons which are to be announced by the government. They haven’t done so in quite some time. But after a local was arrested and charged with illegal sea cucumber harvesting, lawmakers were apparently concerned that the law wasn’t working and so sought to completely eliminate any and all sea cucumber harvesting.

An employee of the Land Grant Aquaculture project in Yap has been in Pohnpei training with Dr. Nair. Palau also sent trainees for their project. The trainee in Yap said that he is closely related to one of the Yap lawmakers who was behind the bill and was told that even though the aquaculture project is located right behind the legislative chambers, most of the Senators didn’t know about it. All they knew was that the law wasn’t working and so they wanted to pass a more stringent law.

However, the problem with the old law wasn’t that it wasn’t strict enough; it was that Yap has very few resources to enforce it. Witnesses to the public hearing in Yap on that law pointed out that making a more stringent law wouldn’t solve that problem and would also kill the aquaculture project.

The law didn’t pass but we’re told that legislators are re-thinking the wording of the law, hopefully to allow for the aquaculture project to continue.

The Land Grant aquaculture program has full time staff members and also utilizes interns from the College of Micronesia FSM’s Marine Sciences program. Dr. Nair says that it’s really his job to work himself out of a job and to turn it over to locals to do. He feels confident that he’s definitely moving in that direction.

The complaint says that while the family was harvesting the sea cucumbers, two Nett Police boats carrying a total of seven Police Officers in uniform approached them and asked them what they were doing. Joseph Edward spoke on behalf of his family and told them that they were harvesting sea cucumbers according to their State authorized permit.

The complaint says that the Nett police officers then demanded, “without any explanation” that the family put back all the sea cucumbers they had harvested. If they didn’t do so they would be arrested.

The complaint alleges that in order to avoid arrest, the family complied but they claim that compliance cost them plenty without due process of law.

Attorney Martin Jano is representing the plaintiffs.

The civil action didn’t mention the ordinance passed by Nett and by U municipal governments banning the harvest of sea cucumbers in their waters until after farming was done and an evaluation conducted. Those ordinances provided for criminal penalties for violators.

The Kaselehlie Press published a story on July 11 on those ordinances and that both municipalities had voted to enforce their ordinances.

The validity of those municipal ordinances has not been determined by any court yet.

“Regardless of what we are called here (‘mehn wai’, ‘ahset’, or something else) I think that ‘Micronesian Blues’ should be required reading for all of us expats before we step off the plane on any Micronesian island,” my review of the book said. I still think so.

I know what happens to books that I love once they hit the screen.

According to the website, TV Series Finale, “Johnathon Tropper is writing the Micronesian Blues ‘crime drama thriller,’ which will be directed by Greg Yaitanes.


They are executive producing with Dempsey and his producing partner and manager, Joannie Burstein. Justin Franklin is co-producing. The Micronesian Blues TV series is based on the non-fiction book of the same name by Bryan Vila and Cynthia Morris.”

TV Series Finale quotes from the “Deadline

Hollywood” site which provides a short synopsis of the story line that is being proposed: “Micronesian Blues, written by Tropper and to be directed by Yaitanes, is based on the true story of Los Angeles cop Bryan Vila, a former Marine who had served in Vietnam, who took a job training local police in Micronesia in the early 1990s, expecting a paid vacation. The series tells the story of a burned out LA cop who accepts a teaching job in Micronesia, only to find himself caught up in a bloody war between tribal gangsters, lawless mercenaries, and crooked CIA agents.”

With a description like that, I wonder if Micronesians will be pleased with the series. It remains to be seen. The authors of the respectful book certainly hope that the series will treat Micronesians with the same respect as they did.

A certain deal has not yet been made.


This trip was very interesting to me and being

## FSM consultations on Convention on Rights of Persons with Disabilities ratification

### Pohnpei, Federated States of Micronesia

The Government of the Federated States of Micronesia (FSM), through its Department of Health and Social Affairs, is conducting a consultation on the Convention on the Rights of Persons with Disabilities (CRPD) in the capital Pohnpei this week, for relevant government representatives and civil society organisations.

The three-day consultation aims to develop the skills and knowledge of relevant stakeholders on the convention and is being supported by the Pacific Community's (SPC) Regional Rights Resource Team (RRRT) in collaboration with Australian Aid and the European Union.

"The training is a very timely event particularly

as the Department of Health and Social Affairs various legislature sittings.

is preparing to submit a resolution on the ratification of the CRPD to the 4th Regular Session of the 19th Congress Sitting of the FSM Government that will be held in September,"

FSM National Disability Coordinator, Stuart Penias, said. According to Mr Penias, the FSM Government endorsed a National Policy on Disability which identifies priority areas for action to promote societal awareness, and inclusion of persons with disabilities, including identification of their needs and opportunities.

The FSM Government signed the CRPD in September, 2011 and is proceeding with plans for ratification this year. The main purpose of the CRPD is "to promote, protect and ensure the full and equal enjoyment of all human rights and fundamental freedoms by all persons with disabilities."

A resolution for ratification was submitted to congress in 2013 which was tabled to allow consultations with the states to get their input and support. Since then, each of the four FSM States - Chuuk, Kosrae, Pohnpei and Yap - have passed CRPD ratification resolution during

# Pohnpeian Atlantis

As a child, I wanted to learn more about my native roots. Curiosity filled my mind and made me eager to listen to every story, legend, and myth known. I believed in most of them until Miller Benjamin, Pohnpeian historian, stated that “most stories were not true.” Superstition has it that if anyone who knows the truth about Nan Madol and shares it will fall very ill and eventually die. Perhaps this traditional belief played a major part in the reason why the formation of Nan Madol still lies a mystery today.

Although the facts of Nan Madol’s origins have been lost over time, as the lies used to confuse both the natives and foreigners intertwine with the truth, we can still find beauty within these mysteries.

As I entered its walkway, I felt the



cool breeze unceasingly coming through the trees that have started to grow on the megalithic structures. A variety of plants grew everywhere except for the path leading to the site. It took me about ten minutes from the parking area to reach the enormous structure that runs a kilometer and a half long and half a kilometer wide surrounding the structure called Nan Douwas. Half-way there I saw an eel desperately trying to breathe in the shallow water. This reminded me that even though the truth of this historical site has been diluted, there is still some truth living within the myths and legends.

Countless stops to admire even the smallest details and listen to stories from a local resident made me thirst more for knowledge. After centuries of wear, the basalt rocks used to build Nan Madol still stand strong to this very day.

“These walls show how strong traditional beliefs were among each municipality”, stated Miller Benjamin. Surprisingly, a prophecy was made for each municipality and today they have been fulfilled. Two of the four corners that surrounds Nan Douwas have trembled and it resembles the loss of culture and strong tradition for two municipalities.

Saudeleurs (or kings) began to become greedy over time—to the point where even a louse picked from the head was not to be killed

by commoners, without permission. The islanders grew weary and tired of the unreasonable dictators of their island. Nevertheless, they continued to show respect to their leaders because it was a declaration they all abided by, willingly. The level of respect that our ancestors held for the Saudeleurs was, astonishingly, a common virtue in the past—a virtue that is rarely for humanity today and lost for humanity tomorrow.

Exploring “the Venice of the Pacific” made me feel proud as an islander. Learning about my roots is a very important civic responsibility because it is how I claim my heritage and how I can identify as a true islander. Respect is not some abstraction in our culture; it is a virtue that binds our people together in unity.

worthy endeavour,” Mr Penias said.

Topics that will be covered during the consultation include Human Rights of Persons with Disabilities, Non Discrimination and Equality including Reasonable Accommodation, Understanding the different articles of the CRPD, CRPD in practise and Monitoring and Implementation of the CRPD.

“While the Pacific Region is slow on human rights treaty ratification, the CRPD is one of the quickest ratified treaties in the Pacific with 10 Pacific Community members having either ratified or acceded to this Disability Convention after it was adopted in 2006 and came into force in 2008,” SPC Regional Rights Resource Team

Director, Mark Atterton said.

“SPC will continue to support the FSM Government as ratification of the CRPD is significant for FSM and its population with disabilities,” Mr Atterton added.

The President of Pohnpei Consumer Organisation, Nelbert Perez, stated that the ratification of the CRPD by Pacific Island countries shows the commitment of Pacific governments towards persons with disabilities in the region.

“Persons with disabilities in the Pacific face numerous challenges which hinder their full and effective participation in their various communities. The ratification of the CRPD allows our governments to take stock of provisions to safeguard rights and identify gaps in order to allow persons with disabilities access to the same opportunities as everyone else,” Mr Perez said.

The CRPD consultation concludes on 4 August.



## GGF teams up with APIC for support of water security in Sapwuafik

The Micronesian Conservation Trust received funds from the Global Greengrants Fund (GGF) (\$5,000) and the Japan Association for Promotion of International Cooperation (APIC) (\$10,000) to support their El Niño and drought recovery efforts on the island of Sapwuafik, Pohnpei FSM. Sapwuafik was selected by MCT and the two donor agencies because it is one of the most populated atolls in the FSM and needs much support. (FSM's 2010 Census lists the population of Sapwuafik at 456). Also, the Mayor of Sapwuafik, the Hon. Kapino Neior, is a very progressive leader and has been actively seeking assistance from various organizations to support the people on his island, so his efforts were rewarded with the funding of these grants.

The work of Mayor Neior shows that communities that are actively seeking assistance for projects to improve the quality of life in their communities have options for fulfilling their dreams. As the old US proverb go, "The squeaky wheel gets the grease", so we encourage communities with good projects in mind to seek assistance for them and help improve the quality of life for the residents of your community.

(APIC) is engaged in various development cooperation projects for the purpose of promoting international cooperation and deepening mutual understanding between Japan and various countries.

Specifically, APIC is engaged in these following activities.

1. Supporting development cooperation projects in the Pacific Island Region
2. Supporting development cooperation projects in the Caribbean Region
3. Organizing lecture meetings regarding global issues
4. Organizing social meetings regarding international cooperation
5. Training young generations interested in international cooperation

Global Greengrants Fund is a charitable foundation that makes small grants to grassroots environmental causes around the world. These funds are used to support community-based groups outside the United States and Western Europe working on issues of environmental justice, sustainability, and conservation. Since its establishment in 1993, Global Greengrants Fund has made over 5,000 grants in 129 countries, giving a total of over \$20 million.

The project's aim is focused on water and food security. The municipal government has used some of the grant funds to buy 8 water tanks that will be placed in strategic areas around Sapwuafik Island to catch rainwater and ensure access by all the island's residents. The tanks have a singular capacity of 1500 gallons and a combined 12,000 gallons of water can now be stored. The municipal government will also use some of the funds to help them rehabilitate/improve some of the taro pits on Sapwuafik which were severely affected during the recent El Nino drought.

He then mentioned about his meeting with the leaders of Pacific Islands Association of NGOs (PIANGO) during which he learned that FANGO has not participated in this regional NGO organization for a while. He personally took responsibility of making contacts with FANGO to revive itself and start

working with the States NGO communities and civil society organizations to work together to strengthen FANGO as the FSM NGO umbrella organization.

He also mentioned that he would not want to see any NGO outside of FSM representing FSM in regional and international forums.

Vice President George expressed his gratitude that Pohnpei is taking the lead and hoped that other States would follow.

Regarding the Theme of the conference: "Enhancing the capacity of NGOs to effectively promote human rights through collective citizen's actions", Vice President said:

"For me, it means we must stand together ready and enhance our capacity to offer assistance to all stakeholders not only to promote human rights but work together to resolve human rights issues. This means working together to promote gender equality, to discourse discrimination against women, and to address human rights issues through collective leadership."

I call on all NGOs and civil society groups in Pohnpei to engage with youth, women, elders, local and state governments, and our national government to work together to make a difference in our lives. I call on all of you to help people understand their stake in our

bold vision to promote and protect our human rights through collective efforts."

Vice President George ended his remarks by stating in its effort to support and assist activities of NGOs and civil society groups and the private sector, National Government has proposed financial resources in the FY17 National budget.

Based on information released by the Pohnpei State Registrar of Corporation, there are 418 State chartered NGOs in Pohnpei State, not counting those that are chartered by the FSM Government. With this many NGOs in Pohnpei, it is essential that a State umbrella organization is established under which all Pohnpei NGOs will become members.

As numbers of NGOs increase, it may become necessary for NGOs with similar mission and purpose to create their own umbrella organization to represent them under the Pohnpei State NGO umbrella organization. They would become the focal points for their group and would facilitate networking among the NGO community. As an example, Pohnpei Women's Council is the women umbrella organization for all women organizations in the municipalities. It is the focal point of contact for the women organizations.

Other special guest speakers were invited to

# Pohnpei State strengthens emergency operation centre management

18 July 2016

**Kolonia, Pohnpei**– Training to help improve the response to emergencies and natural disasters is underway in the Pohnpei State this week, with a focus on strengthening the management of the State Emergency Operations Centre (EOC) and helping the state prepare and respond better to disasters such as strong winds and storm surges which frequently impact the coastlines.



Pohnpei State Lieutenant Governor Honorable Reed B. Oliver in opening the training encouraged the participants to take advantage of the presence of the regional trainers who are facilitating the training so that preparedness for response in Pohnpei can be enhanced and this training is timely as the EOC is being activated more often in response to increasingly frequent strong winds and storm surges events affecting the island.

Participants are from the Pohnpei State Government Departments, Offices, and Agencies such as Public Safety, Agriculture, Health, Education, Transportation Authority, Environment Protection Agency, Radio Station, Public Affairs Office.. Two participants are from the FSM Office of Environment and Emergency

Management as well as one from the Republic of Palau's National Emergency Management Office.

The training is facilitated by regional trainers who are also staff of the Geoscience Division of SPC, Mr. Anthony Blake and Mr Noa Tokavou.

Following the training, SPC will provide support to Pohnpei State Government to develop Standard Operating Procedures for the EOC which will complement the training and provide a foundation for response to future emergencies.

The EOC training, supported by the European Union funded, SPC implemented Building Safety and Resilience in the Pacific Project, is a capacity building initiative to improve the preparedness and response capability to natural disasters.

The training will conclude on Friday 22nd July with a simulation table top exercise and is held at the Governor's Conference room.

## Letter to the Editor

Dear Editor:

I write this letter to you and a copy to our Public Information Officer in the hopes that it clarifies some of the misleading issues circulating in Pohnpei and on the internet regarding the so called sea cucumber harvest. This is a heated issue triggering several protests in the Capital and elsewhere in Pohnpei. And as the event of the sea cucumber commenced, a temporary restraining order (TRO) was filed at the FSM Supreme Court and ultimately was granted. It was extremely unprecedented for the two to happen simultaneously.

The uproar led to the posting on the internet the tallied sheet form used by the Legislative Clerk Division showing the actual vote made by each senator on the subject of sea cucumber. This was the bill on sea cucumber that senators voted upon making it became a law. What the general public and readers did not understand was the intent and purpose of the law thereby making misleading conversations and comments.

The perception by the community in general towards sea cucumber is nothing more than a few of the species of sea cucumber is part of the local diet. Several years back, our communities became aware of the monetary values when foreign businessmen came to buy these sea creatures. Yes, of course, it assisted a lot of Pohnpeians to make ends meet and at the same time contributing to our tax base and the overall economy of Pohnpei. On the other hand, sea cucumbers feed on unwanted sediments and detritus (debris) to make our ocean alive and healthy. For this important reason, we could not overlook the ecological

functions that sea cucumbers provide to our environment mainly to our ocean. If we did not do anything about it, it would have an undesirable consequence to the future generations of Pohnpei--our children and their children and on and on.

To clarify the issue so it becomes plainly understandable and crystal clear to the public and internet users, the intent and purpose of the law on sea cucumber which the tallied sheet showed the vote of a particular senator prohibited or banned sea cucumber harvesting in the waters of Pohnpei state. Those voted "yes" wanted the closure. The only exception provided in the law is when a comprehensive study or assessment is made indicating it is sustainable to do so.

The reason for the protests and the filing of the TRO with the current sea cucumber harvest was that an assessment recently conducted by a professor of the University of Guam reveals that sea cucumber harvesting is not recommended to take place at this time.

I still stand firm in the action of the Pohnpei Legislature as its action helps to balance the social, economic and ecosystem of fisheries so that the future generations can also have what their ocean during their time provides to them. I hope this letter clarifies the misleading issues.

## Man Charged for Imprisoning and Sexually Assaulting Girlfriend

The Attorney General's Office filed criminal charges against a Palauan man on July 21, 2016 for allegedly imprisoning his girlfriend against her will.

Anfon Ridep, who has been confined in Koror Jail since his arrest, is being accused of sexually assaulting, threatening and imprisoning his girlfriend.

The victim identified in court documents as Larinda R. Dick told investigators that Ridep forced her to engage in sexual intercourse presumably while she was imprisoned.

The victim told investigators that the most recent incident began on July 16th to the 19th. Ridep allegedly threatened her with a grass reaper and stuck underwear in her mouth and taped it shut to keep her from screaming or yelling.

In the affidavit of probable cause filed in court, Ridep admitted to imprisoning Dick,

tying her up, grabbing her and leaving marks on her body, threatening her with the grass reaper to "frighten her" as well as stuffing underwear in her mouth to keep her from yelling.

Although he also admitted to tying her up for sexual intercourse he states it was consensual.

Ridep is facing three criminal charges of unlawful imprisonment in the first degree, terroristic threatening in the first degree and sexual assault in the second degree. The charges are Class C felony punishable by 1-5 years in jail and a fine up to \$10,000 with the exception of sexual assault, which is a Class B felony crime punishable by 1-10 years and an optional fine of up to \$25,000.

In his first court appearance on July 22, Ridep entered a not guilty plea. The court ordered bail for \$2,500 cash or \$5,000 surety. He is to remain in jail until bail is posted.

# Habele offers Leadership, Exchange, and Academic Development program

While living with a Yapese host family, Bertha demonstrated tremendous academic focus and ability, earning high marks in all courses of study.

That Habele Tuition Scholarship provided an initial springboard for Bertha’s pursuit of greater social and academic horizons. Through LEAD, she accessed studies and cultural exchanges rarely available to socially vulnerable Outer Island women, spending two months living in the American state of South Carolina.

Formal instruction included courses in filmmaking and cooking and nutrition at the Honors College of the University of South Carolina. Further academic enterprises included preparation for college entrance exams, and visits to local colleges and universities. Additionally, Bertha enrolled in a variety of arts and crafts workshops provided by the Columbia Museum of Art. While maintaining a full schedule of classes, Bertha made time for guitar lessons, karate classes, and even a dog-training course.

Artistic and cultural exchange played a prominent role in the



experience, with the Habele scholar attending a variety of musical concerts, community theater productions, and visiting some of the nation’s premiere museums. These opportunities were complemented by regular participation in the day-to-day lives and social activities of a diverse group of American families.

Leadership development was a consistent theme of the LEAD program. Bertha interacted with local and national leaders, including Katrina Shealy, an accomplished female State Senator from South Carolina who consistently advocates for vulnerable communities. She also met Aumua Amata Coleman Radewagen, American Samoa’s delegate to the United States Congress, and a voice for the international development of democratic institutions. During a trip to Washington, DC, Bertha visited the Federated States of Micronesia’s Embassy, meeting with officials from her national government.

Established by former Peace Corps volunteers, Habele is a US based nonprofit, advancing educational access and accomplishment in Micronesian communities since 2006. In addition to tuition scholarships and exchange programs, Habele provides targeted support for schools, libraries and innovative extracurricular programs.
