

Pohnpei vehicle registration fee increases by 300% for most



Traffic comes to a standstill during the anti-corruption parade in Kolonia, Pohnpei

Pohnpei, FSM—A law tripling the registration fee for most vehicle owners from \$10 to \$30 in Pohnpei is now in effect. Owners of heavier vehicles will pay a higher registration fee.

The Pohnpei State Legislature sent the bill to Governor Marcelo Peterson for his consideration but he vetoed the bill and attached a letter explaining his objections.

“The increase in fees for most, if not all, is more than three-fold; a concern shared by our citizens, more so for the unemployed and those with meager resources. The bill no doubt will have a substantial impact on current and future owners of motor vehicles,” the Governor’s letter said.

“In the alternative, I take this opportunity to recommend proposed legislation to increase sales tax on items such as alcohol and tobacco that have a negative impact on the health and welfare of our people. Similarly, proposed legislation to increase the penalties and fines for criminal offenses, namely for repeat offenders may be appropriate as well,” the letter concluded.

Former FSM employee charged with crimes for allegedly withholding password for Passport system

Palikir, FSM—A former employee of the FSM Division of Immigration and Customs is scheduled to be arraigned on March 14 on National Government charges relating to the alleged withholding of the administrator password for the FSM's Machine Readable Passport system. That system is required in order to print and issue passports which the FSM cannot currently do.

The criminal action information on the charges filed on December 21 by the Department of Justice allege that he was the only holder of the password and that he now refuses to release it after his employment was terminated. Affidavits accompanying the information on the criminal action say that at the time that all of the employees were locked out of the system, there were approximately 100 passport applications waiting to be processed.

On December 27, the Department of Immigration and Customs issued a notice

to FSM citizens that it no longer had the capability to issue passports until further notice.

David Wolphagen was in charge of Information Technology at the Department of Immigration and Customs. Affidavits provided by employees responsible for issuing passports claimed that Wolphagen was the only person who had the administrative password for the system and that when passwords needed to be reset he was the only one who could do it. At least one of the affidavits said that he sometimes reset passwords from off-site but that he never shared the Administrator password with anyone at Immigration.

Six affidavits from witnesses and the investigating officer accompanied the criminal action information filing. One of the witnesses said that Wolphagen had previously said that if he no longer worked at the Division, the system would go down one day and no one would be able to fix it but him.

The investigating officer's affidavit said

Amplifying the voice of youth in Pohnpei to live a drug free life



Micronesian Productions, in conjunction with a Canada Fund for Local Initiatives grant, is working to amplify the voices of women and youth in Pohnpei. Gymnasium, a video on betel nut, produced by Micronesian Productions through a WHO grant through the FSM Tobacco Office was played, and two UB students read their statements to the crowd of over 100 youth present. Then, before the championship games were held, the UB students from PICS High School, Madolenihmw HS, and NMHS all performed songs about living a drug free live and staying away from alcohol and tobacco.

Many thanks goes out to Castro Joab and his staff at COMFSM for playing the recordings of the UB students before every game and to UB Director Diaz Joseph and his staff for coordinating the participation of the UB students in these events. The tournament was a big success in terms of being a drug free event and congratulations to SDA boy's and PICS girl's teams for winning both championship games. In mid-December, the Legislature overturned the Governor's rejection of the bill and the new law took effect on January 1, 2017.

Vehicle registration fees have remained the same since before Pohnpei became a State according to the Justice and Governmental Operations committee report recommending the veto override. That report said that previously \$9.85 of the across the board \$10 registration fee for vehicles had gone to the municipalities where vehicles were primarily parked. The other 1.50 went to the Pohnpei treasury for government operations. None of the funds was specifically earmarked for road maintenance.

The new law finally provides money for the Paved Road Maintenance Fund. 50 percent of registration fees will go to that fund. 25 percent will go to the Division of Police and Security Fund, and the remaining 25 percent will go to the treasuries of the local governments where the vehicles are regularly parked or stored.

The law says that motorcycle registrations will cost \$25 annually. The rest of the fees are a bit harder to define. The law says, "(b) Jeep, Sedan, and other vehicles not specified in Paragraph (c) of this subsection--\$30, and (c) pickups, trucks, buses and other vehicles not specified in the foregoing paragraphs, weight in pounds at the time of original sale in the state of Pohnpei:"

It then goes on to list the registration fees by weight for those types of vehicles. Vehicle owners of that type that are under 2,000 pounds will now pay \$35 per year. Those that have vehicles 2,000 to 2,999 pounds pay \$40. Vehicles between 3,000 and 5,999 pounds will cost \$45 for registration. Vehicles between 6,000 and 7,499 pounds cost \$95. Registration for those between 7,500 and 9,999 pounds cost \$100. Vehicles of 10,000 pounds or over now cost \$350 for annual registration.

The committee report recommending passage of the bill into law said while it is true that the increase is three times the current registration fee, it is also true that the cost of maintaining roads in Pohnpei has increase by 500 percent since Pohnpei became a State. It said that on a daily basis, more than 6,000 vehicles travel the roads in Pohnpei and that each month, 45 new cars arrive at the dock.

Sustainably caught tuna tonnage forecast to double in 2017

Parties to the Nauru Agreement

December 31 2016

Majuro, Marshall Islands—Growing global market demand for MSC-certified tuna and fishing industry interest is expected to see “wild catch” tuna tonnage double from the waters of the Parties to the Nauru Agreement in 2017.

The Parties to the Nauru Agreement (PNA) operates a Marine Stewardship Council (MSC) certified free school caught skipjack and yellowfin tuna fishery in the western and central Pacific fishing zones of its member nations.

In 2016, tuna fishing fleets complying with strict chain of custody rules that met MSC certification requirements delivered over 55,000 metric tons of sustainably caught free school tuna to market, said PNA CEO Ludwig Kumoru. “We expect the volume to double to about 100,000 metric tons in 2017 based upon existing orders,” he said. “With strong fishing industry buy-in for PNA’s MSC-certified fishery, we see the market for sustainably caught tuna continuing to grow. This benefits everyone — the fisheries industry, retailers, and PNA members. Most importantly, catching tuna without using fish aggregating devices (FADs) means tuna are being fished sustainably.”

A “free school” catch means a catch by purse seiners without the aid of FADs. This is verified by onboard fisheries observers at sea where the free school tuna is rigidly segregated in the hold of a purse seiner, and a rigorous chain of custody system is in place through transshipping to a processing plant and finally to the retailer so that consumers know with absolute confidence the story behind the tuna they buy in the store.

“PNA has gone above and beyond what others do (to ensure tuna caught meets

free school catch requirements),” said Bill Holden of the Marine Stewardship Council. He pointed out that MSC certification makes the PNA tuna fishery more transparent. To meet MSC requirements, the fishery is also audited annually and every five years an extensive review is conducted, he said. In addition, PNA has been proactive in addressing conditions of the certification. Holden said a condition of MSC certification for the skipjack tuna fishery was development of “target reference points” for the tuna stock. This was developed by PNA and adopted as policy for this fishery by the Western and Central Pacific Fisheries Commission at its 2015 annual meeting, he said.

The next step is a harvest control strategy, which PNA is now engaged in developing for endorsement by the WCPFC, Holden said.

PNA Commercial Manager Maurice Brownjohn, who has developed the certification and chain of custody systems from the start, said MSC certification is the “gold standard” for fisheries sustainability. “MSC-certified skipjack and yellowfin from PNA waters now accounts for over 90 percent of all MSC-certified tuna being traded globally,” Brownjohn said. “PNA’s MSC chain of custody system is now seen as the global standard for free school caught tuna.”

From the initial MSC certification in December 2012, it took another year for PNA to develop and implement the rigorous chain of custody and traceability system before tuna was marketed as MSC-certified sustainably caught fish.

In addition, pointed out Mr. Kumoru, “at the outset of PNA’s move to meet MSC standards in our fishery, a number of industry players objected to PNA raising sustainability standards for the fishery and even attempted to block us through

The committee report rejected the Governor’s recommendation that the Legislature instead look at increasing penalties and fines for criminal offenses. It said that the Pohnpei Constitution bars the setting of excessive bails or fines, so that method of raising revenue would be constitutionally banned.

The report argued that if a person can afford to purchase a vehicle for thousands of dollars, the person “most likely” can also afford to pay for the privilege of using public services like roads. “Thus, your Committee believes that it is consistent with our reform policies in revenue generation to sustain essential

public services moving forward.”

The law says that registrations shall expire and should be renewed each year in accordance with a monthly schedule established by the Director of the Department of Public Safety. It then codifies a requirement that the rules and regulations regarding expiry and renewal dates of registration be based on an alphabetical identification numbering system based on last name or the first noun in the name of a company or other entity.

That system has been somewhat problematic for enforcement in the past. DPS quite frequently runs out of license plates with the correct first letter of a



legal interventions. But PNA withstood these challenges and has demonstrated the viability and financial benefit of free school caught tuna. Today we are seeing strong industry participation to provide MSC-certified tuna to consumers.”

Since 2014, the volume of MSC-certified tuna from PNA waters marketed globally has continued to increase exponentially as more industry players see the benefit of participating in the scheme.

Fishing vessels that deliver free school caught tuna that meets the strict sustainability guidelines get as much as \$100 per ton extra, and retailers are able to sell this tuna at a premium because it is sustainably caught.

The PNA established Pacifical as its marketing co-brand for pMSC-certified tuna, which in turn is paying dividends to PNA members from this Pacifical tuna marketed in Australia, New Zealand, Europe, USA and elsewhere. Retailers are paying up to a 20 percent premium for MSC-certified Pacifical tuna compared to tuna caught using FADs.

“There has been huge buy-in by private tuna labels and growing interest from brands globally,” said Mr. Kumoru. “Today, over 200 purse seiners are participating in the PNA scheme, which is why we anticipate the volume of MSC-certified tuna delivered to market to rise to 100,000 metric tons in 2017.”

vehicle owner’s name. When that happens they often issue license plates with the incorrect first letter. It makes it difficult for police officers on routine patrols to easily tell from looking at a license plate whether the vehicle is properly registered or not. Further, when a vehicle owner goes to DPS to renew their vehicle registration, it is not uncommon for the traffic section to try to charge a late registration fee for a vehicle owner who is in compliance with the law but who was

issued a license tag that does not reflect the name of the owner. It sometimes requires a bit of explaining even though the vehicle owner’s registration card clearly lists the name of the owner and the date of previous registration.

Local Stressors, Resilience, and Shifting Baselines on Coral Reefs in Kosrae

A study from Kosrae was just published examining how reefs and fishes may have changed over a longer period of time that we typically can observe in our lifetimes. Historical baseline data from Kosrae was used to examine changes in fish and coral assemblages since 1986 to present day. This historical dataset was collected by the Army Corps of Engineers for all FSM states, however, many historical reports get lost over the years or data become unavailable as computers die out. In Kosrae, a copy of the report and all datasets were preserved with both Katrina Adams, from the Kosrae Village Resort, and the Kosrae Conservation and Safety Organization (KCSO), prompting the study.

ecosystem resilience over the years, as fish composition shifted to smaller species in lower trophic levels, driven by losses of large predators and herbivores. Lower resilience means that corals take longer to recover from small stress events, such as extreme low tides, bleaching, or passing large-wave events. While prior literature and anecdotal reports indicate that major disturbance events have been rare in Kosrae, small localized disturbances coupled with reduced resilience may have slowly degraded reef conditions through time. Improving coral-reef resilience in the face of climate change will therefore require improved understanding and management of growing artisanal fishing pressure and a greater focus on watershed pollution in the few urban areas that exist.

This study was complimented with a second study that is nearly completed, where a more detailed look at catch records for key fish species behind the changing reefs was examined. Together, these studies hope to define tangible ecosystem-based management objectives for reef fisheries, and we plan to start translating the results with the KCSO partners in more detail this upcoming year.

The work in this study represented the Master's thesis for Mr. Matt McLean, and included many project partners: KCSO, Kosrae Department of Resources and Economic Affairs Division of Marine Resources, Kosrae Island Resource Management Authority, and Dr. Peter Houk's research lab at the University of Guam. This project was funded through the US National Fish and Wildlife Foundation, and the Micronesia Conservation Trust. A copy of the study can be obtained by emailing to houkp@ugam.uog.edu

Despite the small island size and limited human population growth over the years, substantial shifts in the way coral and fish species were distributed around the island were found. Resources that were once in the best condition (plentiful coral growth and high numbers of large-bodied fish) on the western, leeward side of the island have been hit the hardest by fishing pressure, as leeward reefs offer protection from the prevailing northeast waves and greater access for fishermen over the years. In turn, the wave exposed east coast is slowly becoming a refuge for framework building corals (i.e. table corals such as Acropora), and larger herbivores and predators. This does not appear to be unique to Kosrae in Micronesia, but the rare look into a past window helps resolve how change may have occurred.

The results of the study suggest that unsustainable fishing has slowly reduced

that he accompanied Chief Ricky Falcam to speak with Wolphagen at his residence. He testifies that Wolphagen refused to provide the administrator password and insisted that they leave his house and not return.

Another of the witnesses testified that Wolphagen did return all tangible property to the Division and an inventory was completed for those items.

The FSM Department of Justice has charged him with three criminal counts. Count one is "Obstructing Administration of Law and Other Government Function". The penalty for that crime is not more

than one year in prison. Count two is "Retaliation for Past Official Action". The penalty for that crime is imprisonment for not more than 10 years. Count three is "Tampering with Public Records or Information". The potential penalty for that crime is imprisonment for not more than one year.

Wolphagen has not yet entered a plea and is presumed to be innocent. His arraignment is scheduled for March 14 at the FSM Supreme Court. It is at that time that he will enter a plea of "guilty" or "not guilty". If he pleads "not guilty" a trial will be scheduled at that point.

Again, he is presumed to be innocent unless proven otherwise

Mwoakilloa Treasurer charged with alleged theft of over \$13,000

Pohnpei, FSM—Deetor Lebehn, has plead “not guilty” to charges related to the alleged theft of over \$13,000 from the Mwoakilloa government while he served as treasurer there.

A May letter to Chief Magistrate Mason Henry from the Office of the Public Auditor said that Henry visited the office of OPA in February asking them to look into why there was only \$85 in the Mwoakilloa operating account at the Bank of the FSM. He wanted to know also why there was on \$7 in its project account at the same bank. He told the auditor that vendors were calling seeking payment for outstanding bill the government simply didn’t have the money to pay.

Pohnpei OPA conducted a complete review of financial transactions from fiscal year 2013 through the first quarter of fiscal year 2016. According to OPA’s management report, over \$11,000 of total were for 60 checks written to the treasurer. \$4,126.48 was for “salary purposes”. \$3,656.70 was

for travel reimbursements. \$1,412.00 was for car repair reimbursement, and \$1,158.15 was for “other expenses”. In addition to those checks there was one for \$3,000 for Lebehn to participate in a Nigerian internet scam. As happens in those cases, that money was totally lost.

There were several other problems at the municipality including employee charges for fuel that were never repaid and several other irregularities but Lebehn’s alleged offenses were sufficient for OPA to recommend prosecution.

The government filed a criminal information at the court listing 40 separate charges for individual acts many of them similar but for different instances of alleged criminal activity.

Prosecutors say that a trial date has not yet been set and that there is some consideration for a change of venue because most of the witnesses are in Mwoakilloa.

Lebehn has pled “not guilty” and is considered to be innocent unless proven to be otherwise.

Fiber optic repair means slow internet in Pohnpei and almost no internet services in RMI

FSMTC had bought backup bandwidth and taken other steps to minimize the impact

Pohnpei, FSM—The fiber optic line that provides data and voice service to the FSM was as “offline” as it could get as of 7:45 on December 28. The branch that services the Marshall Islands also had to be turned off. Fiber optic service to the two nations will remain offline until the owners of the HANTRU1 cable that stretches across the ocean floor from Guam to Kwajalein, Marshall Islands is able to finalize repairs to the cable.

The estimated date for completion of repairs has changed several times since the project began as new faults were found. At press time, the ship’s schedule listed the completion date for repairs as January 18, but a spokesperson for Truestone, one of the owners of the cable provided a different date in an email to FSMTC. “There were a number of technical challenges locating the fault,” he wrote. “We have now found the fault and have started the process of making the repair. The current schedule shows the repair complete between 1/21 and 1/24. The later date includes contingencies due to bad weather or other unexpected circumstances.” By press time, FSMTC was unable to ascertain which of the dates is actually correct.

Both MINTA (Marshall Islands National Telecommunications and Authority) and FSMTC (FSM Telecommunications Corporation) are customers who pay for services on the line. Neither was responsible for the repairs that are underway.

When the fiber optic cable was shut down for repairs, the Marshall Islands all but shut down. The College of the Marshall Islands rescheduled its start up for the spring semester because of it. The Bank of Guam said it couldn’t process allotments as it had previously done. The government could not process purchase orders or payments because they were web based. Home users were entirely cut off and businesses had very limited daily access and had to schedule it. Many could not, and some had services of an hour or less per day if that. This evening, MINTA proudly sent a mass message to users saying that effective today Internet connection would be available to government offices and business during working hours and that home users would have access from 7 PM to 7 AM.

The front page of today’s Marshall Islands Journal says that MINTA had finally bought \$40,000 worth of bandwidth.

FSMTC customers have not had it

nearly so bad. Because FSMTC had arranged to send the O3B transmissions to a provider in Hong Kong instead of routing those transmissions to Pohnpei and then out through the fiber optic cable, those customers have seen slightly faster Internet connection than they had previously. Pohnpei customers who have the greatest demand for Internet services nationwide have suffered the most during the repair.

Like MINTA, FSMTC initially shut down home ADSL but only during the 8 AM to 5 PM working hours in order to let commerce flow, even if more slowly. No businesses had to queue up or schedule internet hours. The repairs were only supposed to take a few days, but the Tyco crew making the repairs off the shore of Kwajalein found more extensive damage than they had initially thought there might be and the end date for repairs was rescheduled several times. FSMTC bought more bandwidth and at 3:30 in the morning on January 10 began using that bandwidth to provide service to their home ADSL users 24 hours a day.

Bandwidth is a measurement of how many bits of digital information can be transmitted per second over a medium like fiber optic cables. The telecom providers sell bandwidth packages that they are expected to provide to their subscribers. How much bandwidth a telecom provider needs depends on the bandwidth packages it has sold and the expected number of users they expect to be simultaneously accessing the fiber optic cable at any give time.

The HANTRU1 cable and its spurs have maximum capacities of 160 Gbps (giga bits per second). Half of that is available FSM and RMI but neither has purchased anywhere near that amount.

FSMTC has purchased “pipelines” that allow them to access 4 Gbps if they absolutely need it, but they never have come even close to needing it. FSM wide access needs average about 1 Gbps for both Internet and long distance phone services, but the standard deviation on that average is quite high. At about 10:00 each evening, as ADSL customers are watching Netflix movies or doing other things on their computers at home, Pohnpei’s data demand peaks at about 1.2 Gbps. In the wee hours of the morning the fiber optic demand is quite small for quite a while.

There are also monthly peaks. On the second Tuesday of each month,

Microsoft sends out patches and updates to Windows users. On that day, the incoming data demands peak drastically as thousands of computers across the FSM download those updates over the course of the next few days. Microsoft’s most recent update was sent two days ago. Given the already small bandwidth availability, Internet service became noticeably slower. Other major software companies also send updates at about the same time, further draining already limited bandwidth.

Both FSMTC and MINTA (Marshall Islands National Telecommunications Authority) have known for months that the repairs were scheduled but seem to have made substantially different types of preparations to cover the loss of bandwidth that the fiber optic cable provides.

MINTA prepared a backup plan with its satellite service provider for 50 Mbps (megabits per second) for the entire nation, 3% of its average bandwidth, all but shutting down Internet services and also interrupting some voice services.

FSMTC worked with its satellite provider (ABS-Satellite) to facilitate 197 Mbps of new bandwidth. When the repairs began, FSMTC already had the backup bandwidth in place divided as follows:

- 101*/30** Mbps for all Pohnpei only internet traffic.
- 20/20 Mbps for international voice traffic in/out of FSM.
- 5/5 Mbps additional for Chuuk voice traffic.
- 4/4 Mbps additional for Kosrae voice traffic.
- 4/4 Mbps additional for Yap voice traffic.

At 3:30 on Tuesday morning, FSMTC turned on an additional 100 Mbps download speed and 30 Mbps upload



speed that they acquired from their satellite provider at an additional cost.

O3B mid-range orbit satellites can provide close to fiber bandwidth. O3B satellites have a much lower orbit than traditional satellites so can minimize what is called “latency”, the time it takes to transmit a signal to the satellite and for the signal to travel back to another point. It is what FSMTC is using to provide service to Chuuk, Yap, and Kosrae. FSMTC could possibly have chosen to utilize that technology but the initial investment for it would have been \$300,000 for terminals and activation. It would have made no economic sense to make that investment for backup bandwidth considering that they are already set up with ABS, their satellite service provider.

Even though the slow connection speeds were not their fault FSMTC has said that they intend to credit Pohnpei customers for their ADSL subscriptions for the number of days that the fiber optic cable is down.

FSM ratifies the Convention on the Rights of Persons with Disability

Persons with disabilities are entitled to be full and equal members of society, to live in dignity, to control their own lives, and to make their own choices. In fact, these values are not far from our own national Constitution, which upholds a range of rights including freedom from discrimination, and acknowledges that, just as “The seas bring us together, they do not separate us” and “Our island nation enlarges us and makes us stronger”; so too, “Our differences enrich us.” The Convention on the Rights of Persons with Disabilities or CRPD represents a radical transformation in the way we look at disability and those with physical, sensory or mental impairments. Importantly, we understand that there are challenges that arise from the social prejudices and other environmental barriers. It demands that we recognize that persons with disabilities have inalienable rights like everyone else; that they are part of the rich mosaic of humanity and human diversity; and that there is value in difference.

an overwhelming mandate from all four states following the passing of resolutions in support of ratification.

Article 32 of the CRPD states that there are international donors who will support CRPD ratified nations financially through grants and other means. This means that a new door will be opened for support for persons with disabilities. The biggest concern from the FSM is that it will be the most expensive treaty of all, but that’s not true. The States will need to gradually make improvements using their available resources.

The function of the CRPD is to open people’s eyes, ears, and hearts, to educate them and spread awareness. The FSM will need to begin placing significance on the accessibility of disabled persons to all public areas such as wheel chair ramps and elevators.

The CRPD ratification is such an important step for the people of the FSM as it shows that the people and its leaders put significance in the well being of everyone, including disabled persons.

The FSM took an important first step towards ratifying the Convention nearly five years ago. In the September 2016 Regular Session, the 19th FSM Congress ratified the convention with

She further said that "the training was very successful because all the participants were able to do hands-on and put into practice all the lessons that were discussed." Aside from trying to provide quality education to the students, OLMCHS is also trying its best to put in place the safety procedures of the school. Last September 9, 2016, IOM gave a workshop on School Emergency Management Plan (SEMP). Through the guidance of IOM, OLMCHS was able to formulate its SEMP and had a series of school-wide fire and evacuation drills. In November 7, 2016, OLMCHS successfully passed the Hazard Specific School Emergency Management Plan and fire drill with IOM and the Pohnpei State Department of Public Safety - Fire Division.

Kolonia Town retailers renew their efforts for responsible alcohol sales and service

The New Year allows EC to review a little and catch any new readers with the story of Mr. Navarro Navarro. A young 22 year old Navarro begins his teaching career in a Roman Catholic School about the time of FSM Independence. He is hired as a last minute replacement for the regular 5th grade teacher who had taken severely ill. Navarro has the minimum requirements, a Bachelor's Degree from an accredited college but he has no teacher education. We learned he was an excellent student himself and is very confident in the curriculum he will teach—that is he knows what to teach. However with no teacher training he has never learned the methods and strategies teachers use to teach—or how to teach. The young man has only his own experiences as a student and using those good experiences and good teachers he jumps right in and begins teaching the morning after he was hired. Readers have been asked to join Navarro in his journey to become a teacher. Readers can be assured Navarro makes mistakes but he learns from them. EC has been writing little stories about Navarro and asking readers to think like students and think critically. We use critical thinking questions which just mean the student or reader should explain the answer.

Navarro Continues

But how would the young man teach spelling, reading and writing? Navarro could barely remember how he learned to read English. It seemed one week he was not reading and the next week he was. He was a terrible speller and yet he had always received an A in spelling on his own report cards. He thought back and remembered how he easily memorized the 20 words usually just before the Friday spelling test and he rarely missed a single word. The unit tests or review tests took him a bit longer to memorize 100 words. Even though he had received his A's on the weekly tests, he always had to memorize the 100 words before the review test. But he wondered why he was such a poor speller? In college, he never wrote a single paragraph without a dictionary by his side and he was forever looking up the same words over and over. The 5th grade speller held the answer. The spelling book was just like the one he had in the 5th grade. The new words for the week were on a first page and then 2-4 pages of exercises using the words and rules to follow with spelling certain types of words. He knew without even thinking—make sure the 5th graders learn the spelling rules so they would not end up like him always looking up words over and over again in a dictionary. The spelling book also had the all important grammar rules. That together with his Teacher's Edition gave him even more confidence in the English language arts. Just because Navarro had always gotten A's in spelling did not mean he was a good speller. All of this worried Navarro at the idea of grading papers and tests. He had received A's in spelling yet he could not spell. Something was not right about that.

But with so little time Navarro did not have much of a chance to train himself about how to teach. He was, however, confident about a few things. He wanted to make the students curious about learning. He had learned better when he enjoyed the lessons and actively participated in them. He had liked the hands-on lab work and science fairs. Good films

especially for history would be better at times than just talking about history. History holidays could be a good idea as well. Memorization of facts or words did not necessarily mean that those facts or words would be remembered. He was still confused about how he would grade but he had a few good ideas about how he would try to teach. But in the back of his mind he also knew that not all of his students would be learning the way he had learned. Many of his own classmates hated science and hated history even though teachers tried to make classes fun and interesting. This fact bothered him so he knew he would have to learn more than just throwing a blanket over a kitten or showing a film. And his best friend Jimmy Devine got a D in history and he got to dress up as a knight at the Medieval Fair. Learning how to teach might take quite a while," he thought. "Quite a while indeed."

Then Navarro's thoughts were interrupted. They were interrupted by a nicely printed note signed by the principal Sister Mary Francetta. It read:

Dear Mr. Navarro:

On Fridays I usually have the teachers leave their lesson plans for the following week. I check to see if they are complete and leave them on the desks for the following Monday morning. As you are just getting acquainted with teaching 5th grade I will not be checking your lesson plans until the second Friday of the semester.

Also the 8th graders will love you for science after only one day. It is good that they are enjoying the class but do be sure they are learning something. Be sure and test them every week. In fact be sure you are giving your tests on a regular basis in all your 5th grade subjects. We usually do testing on Fridays and that way we have the weekend to do the grading.

Finally the 5th graders are just wonderful for the religion class. Father O'Hooligan visited the class and blessed the classroom.
