Concerned about well-intentioned death from above, two FSM Governors call for cancellation of Operation Christmas Drop

Pohnpei—On November 23 and 24, the FSM Department of Foreign Affairs forwarded to the U.S. Embassy to the FSM, two letters written by two FSM Governors requesting cancellation of the 69th Annual Operation Christmas Drop which is set to happen on December 5.

“Pohnpei State COVID-19 Task Force ha(s) carefully reviewed the health risks Involved and, with regrets, advise(s) that it is in the best interest of our people and everyone who cares for us to reconsider and hold off on this year’s Christmas Drop,” wrote Pohnpei’s Governor Reed Oliver. “The vulnerability of our outer island populations toward potential outbreak of this contagious virus, COVID-19, is a risk too high and a cost too exorbitant to leave it to chance. It is better to err on the side or caution than to risk lives under this very vulnerable circumstance.”

“...I deeply regret to inform you that I have received written requests from the Council of traditional chiefs of the Yap outer islands, formally

Pohnpei Legislature expected to issue resolution objecting to December 5 repatriation flight

Pohnpei—Members of the Pohnpei State Legislature met with President David Panuelo on the morning of Friday, November 27 asking him to call off the small repatriation flight from Guam scheduled for December 5. According to Senator Shelten Neth, the Legislature’s Chair of the committee that handles health and social affairs, the President would not agree to call off the flight.

Neth says that the Speaker is calling for a special session during which it is anticipated that the Pohnpei State Legislature will pass a resolution registering its official opposition to the repatriation flight.

At this date, the repatriation flight is still at this moment tentative according to a Presidential press release. According to that release, the 41 people who are scheduled to be on that flight, which includes diplomats attached to an Embassy in the FSM, stranded medical referees, and students, each had to present a negative COVID-19 test before they could enter the official FSM quarantine site in Guam. Access to that site has been restricted and “there are multiple more COVID-19 tests during the pre-quarantine process”.

“Upon arrival in the FSM,” the President continued, “all repatriating persons will

be tested for COVID-19, electronically cleared through Immigration and Customs with no physical contact, and immediately escorted to the designated quarantine facility, which carries a minimum 14-day experience. All repatriating persons and onsite medical staff, who will live in the quarantine site for the duration of the repatriation, will be tested for COVID-19 multiple times. National and State law enforcement will ensure the quarantine site is secure and that access and visitation are prohibited. Every single repatriating person will undergo the same COVID-19 testing and security protection regime.”

While the Pohnpei State Legislature may register its objections, the President’s press release makes it clear that “only the FSM COVID-19 Task Force can make decisions on the repatriation process with guidance given to them by the 21st FSM Congress through Congressional Resolutions extending the Declaration of Public Health Emergency. Decisions being made for repatriation efforts are collectively developed in the FSM COVID-19 Task Force, in close consultation with the State Task Forces; no single individual, to include elected and appointed officials, can, or does, unilaterally make repatriation decisions on a case-by-case basis,” it said.

“I have demanded an airtight repatriation regime, and that is precisely what we’re doing,” His Excellency David W. Panuelo, President of the FSM, said in a statement.

“Ever since our border closed in March, our citizenry ha(s) been split into two distinct groups: those who wish to maintain the border closure until the Pandemic is no longer a threat, and those who wish to reunite with loved ones stranded abroad. As your President, I am obligated to protect and secure our Nation’s borders and to keep you safe from external threats. We remain COVID-19 free, and we are implementing an airtight process to keep the COVID-19 virus out. I will not allow community transmission of the virus in our country. That said, I am not only the President to those of us here at home, but also to our brothers and sisters abroad. I am responsible for all of you, and I am committed to ensuring our citizens return safely home while our Nation’s citizens in the FSM remain safe from the virus,” the press release said.

Some of the arriving diplomats who live inside gated communities will be allowed to home quarantine but that process also will be monitored.

“I’ve asked our Task Force to keep me updated on the development of vaccines, and there are positive developments on a vaccine that will be available soon in the months to come. Our Nation has reserved adequate funds, in the millions of dollars, that we can purchase an effective vaccine to cover 100% of our population, beginning with frontline workers and vulnerable members of our society. Until every person is vaccinated, our border must remain closed—but we remain committed to bringing our stranded citizens home safely,” the President’s press release concluded.

FSM Government fires DeOrio and Oliver for “leaking” document regarding “public project”

FSM—After having suspended Mark DeOrio and his wife Norleen Oliver without pay in mid-October, the FSM Government has now taken the step of terminating their employment. Both DeOrio and Oliver are facing criminal charges related to actions taken to attempt to block a “public project” that would pave a road through the land they occupy that leads only to Patricia Edwin’s family home.

The separate letters that National Police delivered to DeOrio and Oliver on November 18 said that they had 15 calendar days to submit a written appeal to the action. According to Oliver, the Government isn’t forthcoming with information on exactly what should be done. She said that her husband’s attempt to meet with the Department of Personnel for information on policy and other information pertaining to their employment and the process of appeal was “met with great resistance.” She said that he was told that a memo had been circulated within the National Departments that instructed employees to refrain from communicating with DeOrio and Oliver, but that the memo had been labeled “confidential”.

Indeed, according to the FSM Public Information Officer, employees have been instructed not to discuss the ongoing matter and he could not do so.

Each letter to DeOrio and to Oliver said that the Department heads were taking the termination action based on a written recommendation from the Department of Justice. The terminations were issued for:

- “Stealing of official information”;
- “Breach of Executive Privilege consisting of a communication between President and Cabinet member”;
- “Conflict of Interest”;
- “Violation of Executive Order No. 1 (2008) as amended which delineates the mandates of the several divisions of the Department of TC&I”

DeOrio is criminally accused of charges similar to those listed in the reasons for the government’s decision to terminate his employment but his case has not yet been heard. The felony charge the government filed against his wife was already thrown out by the time the government fired her. The remaining misdemeanor charge against her has nothing to do with the government’s listed reasons for firing her.

“Taking into consideration the proposed termination and the explanation you offered, the Government has decided to terminate your employment. The Government is of the view that your termination will serve the good of the public service,” said TC&I Secretary Apis’s letter of termination to DeOrio. Earlier in the letter he wrote, “I am convinced that your termination from employment is warranted and in the best interest of the public service.”

The Secretary of the Department of

Health and Human Services, Livingston Taulung’s worded the likely DOJ issued wording more tersely. “I have decided to terminate your employment effective today upon your receipt of this notice. This termination serves the good of public service.”

None of the cases filed at the FSM Supreme Court against DeOrio or Oliver have reached anything like a final disposition, and Oliver’s civil action is also still in preliminary stages.

Pohnpei COVID-19 Task Force releases excellent video drama every Micronesian should see wherever they are

Pohnpei—As Pohnpei has sought to remain COVID-19 free and ensure that its people are safe if it should arrive, the Pohnpei COVID-19 Task Force released many advisories and safety warnings—warnings that Peterson Sam, Commissioner of Pohnpei State Radio and member of the Task Force felt were being largely ignored. He said that Pohnpei still has risk factors even though the borders are currently closed. He felt that the Task Force should put out something more compelling; something that would show rather than tell what COULD happen to hopefully motivate viewers to begin to practice safety guidelines.

Peterson said that despite rejection of the idea from some funders and even some members of the FSM Task Force, Pohnpei Governor and Lt. Governor and the Pohnpei Task Force stood behind the idea and provided funding to create the video “Irair Wet Kak Lelehng Komwi” (This could happen to you) which the Task Force released in its final form within the last two weeks. Readers can view the video by

Googling the name.

The organizers made a strategic error when they released a trailer for the video in early October with the caption “Coming Soon”. That caption was to say that the video was coming soon but many people read it to mean that COVID-19 was coming soon. The comments on the video were overwhelmingly negative, most saying that the trailer was far too alarmist, and certainly, without the context of the story line, it was.

However, the final product, while still alarmist, carries an important and true message that is extremely well done and carries an engaging story line. All of the actors took the task seriously and many of them performed like veterans of video drama. The thirteen plus minute video devotes the last three minutes to deliver important information about the effect and spread of the novel coronavirus and how it can be contained. It does not hide the fact that the percentage of people who die from the virus is still quite low and hits those with pre-existing conditions the hardest. Yes, it is alarmist but it is a needed message.

Peterson created the basic story idea and sent

it to Landon Cook of LSC Video Production Company in Utah. Cook wrote the script and sent back story boards. Micronesia Productions recruited the actors and filmed the multiple camera angles for the engaging video. They sent all of the footage to Cook who edited it all into the final product which moves quickly and dramatically.

If all you have seen of “Irair Wet Kak Lelehng Komwi” is the video trailer, you have not seen it. The story line made this

editor cry because in fact, “this COULD happen to you”. If you haven’t seen it and have only heard the negative comments, I suggest that you give it another chance. With easy to follow English language subtitles, it is a video that I feel every Micronesian wherever they are should watch and take at least a moment to think about.

Kudos to the Pohnpei COVID-19 Task Force for carrying on despite the nay-sayers.

recognized as the Council of Tamol, and our Yap State COVID-19 Task Force Leading Agency, Yap State Department of Health Services, to respectfully inform you to convey their regretful request to our friends at the U.S. Embassy to kindly cancel the Christmas Drop operation for this year, if it is still possible, particularly for the Yap Outer Islands," wrote Yap's Governor Henry Falan. This request is made due to the risk and fear of introducing COVID-19 into our vulnerable islands and people, since our borders are still closed, and I do hope that this special tradition will continue in the years ahead when COVID-19 is no longer a threat to our people.

Both Governors expressed deep regret for the need to cancel the airdrop which was scheduled to begin on December 5 and also for all of the work and time that has already gone into the preparation for the drops. "This annual tradition of Christmas Drop by the U.S. Air Force has been a special tradition of love and care between our two nations and it has been in practice for many decades. It is also a tradition that uplifts the Christmas spirit in the lives of people of all ages on these remote islands including children and adults over many decades during this time of year," wrote Governor Falan. Governor Oliver expressed similar feelings.

On November 25, an online publication of the Pacific Air Forces published an article entitled, "US, Japan to kick off Operation Christmas Drop despite COVID-19". The article describes the extensive safety precautions to guard against COVID-19 transmission potentially being carried

from dropped cargo on what would have been the 69th iteration of the Department of Defense's longest annual, bilateral humanitarian and disaster relief training mission.

According to Bruce Best, even if the FSM elects not to participate, the Christmas Drop will continue into its 69th year at least in Palau which has not to date expressed any desire to cancel it. "...Very sad for the outer islands," he wrote. "We even had extra tools for Kapingamarangi to help repair rain catchment." Though the atoll island of Kapingamarangi has recently received some rain it has been in the grips of a severe drought requiring outside aid for some time now.

US Charge d'Affaires Somer E. Bessire-Briers said that at least as of today, the FSM has not yet made an official request to cancel the drop entirely. She said that she had received a communication from FSM President David Panuelo that he was trying to work on a safe way to administer the drop and that she expected final word would come by Monday, our print deadline day.

Best said that the FSM had bandied about the idea of just dropping all the boxes to the State centers for the States to later transport the items to the outer islands. He said that plan doesn't take into account things like expiration dates on donated items, USDA restrictions, or the fact that the New Zealand, Australian, Japanese and other armed forces are spending money to be involved specifically to learn and to practice the low level drops that the United States Air Force does.

He said that the pilots, crew, commanders and other military personnel involved in Operation Christmas Drop are anxiously awaiting updates since they will need to deal with the details of changed logistics.

Samaritan's Purse donates two aircraft to Pacific Mission Aviation

Tamuning, GUAM- For 46 years, Pacific Mission Aviation (PMA) has provided services such as medical evacuations, sea searches, disaster relief and more, for islanders in isolated islands.

The pandemic has brought on many challenges this year with an ever-increasing demand for flight services. There was urgency and need for better and faster equipment to expand PMA's reach to adjoining states and countries in the region. In order to enhance their capabilities, they looked into grants to support the purchase of the Beechcraft King Air 200, training of pilots and mechanics, as well as spare parts.

On November 8th, the organization contacted Samaritan's Purse, who happened to have two Beechcraft King Air 200's that were already outfitted for mission work, with extra cargo carrying capabilities, strong landing gear, and many other enhancements.

Four days after the initial contact, PMA



received correspondence directly from Franklin Graham, CEO of Samaritan's Purse, asking for more details about the Mission and the need for these aircraft. Two days later after several back and forth emails, Franklin Graham called Nob Kalau, CEO of PMA, and informed him that Samaritan's Purse was going to donate these planes to PMA.

Samaritan's Purse was prepared to assist PMA as best they could to integrate seamlessly into the world of turbo-prop powered aircraft. Franklin Graham committed to preparing the planes so that when they arrived in Micronesia, they would be ready to serve. This included the training of three PMA pilots and

three mechanics, upgrading the avionics on both planes, and even exchanging components that were nearing their life limit such as one engine and two propellers.

"These aircraft are tools that PMA will utilize to extend the vision of Samaritan's Purse, which also mirrors PMA's vision in Micronesia of - Bringing Hope, Changing Lives," said Norbert Kalau, President and CEO of PMA. He went on to say that "the donation of these aircraft brings in a new era of extended service, increased safety and spreading God's love to the people of Micronesia. PMA is deeply thankful to Franklin Graham, and the generosity of Samaritan's Purse."

More than 100 people benefit from free Health Screening on World Diabetes Day

KOLONIA, Pohnpei -- On Saturday, November 14, 2020, to mark World Diabetes Day, healthcare workers from the Pohnpei Community Health Center and Pohnpei State Division of Public Health conducted free community health screenings for people in Pohnpei State. The event, which was organized by the FSM Non-Communicable Disease (NCD) Program and the UN Country Team in the FSM, was part of an ongoing UN Focus Dialogue National Awareness Series to commemorate the 75th Anniversary of establishing the United Nations.

A total of 106 people benefitted from the services, which included free blood pressure checks, blood sugar examination, cholesterol tests, dental screening, eye clinic and chiropractic assistance. The beneficiaries also received information and education materials intended to keep enforcing the key messages on diabetes and other non-communicable diseases.

Japanese private foundation supports Kapingamarangi drought recovery

Embassy of Japan

In the wake of the severe drought which hit Kapingamarangi Atoll, the Association for Promotion of International Cooperation, or APIC, decided to donate 20,000 US Dollars for the purpose of purchasing 8 units of 1,000 gallon water tank in Pohnpei Island and shipping them to Kapingamarangi Atoll.

APIC is a private foundation based in Tokyo, whose aim is to strengthen relations between Japan and nations in the Pacific and the Caribbean.

For the Federated States of Micronesia, APIC has implemented various development projects in the FSM as well as invitation and scholarship programs in Japan for both the leaders and the youth of the FSM. The assistance by APIC to Kapingamarangi was decided upon the request from the Micronesian Conservation Trust (MCT) for the cooperation. Earlier this year APIC already donated through MCT also 20,000 US Dollars to Weno, Chuuk State, which had been severely affected by a drought, for the installation of 10 units of water tanks.

The handover ceremony for

Kapingamarangi was held on Tuesday 17 November 2020. The Hanover Ceremony for Kapingamarangi Drought Recovery and Support for Conservation Equipment held at the Pohnpei State Government building from 4 pm for about 30 minutes, was attended by Pohnpei State Governor Reed Oliver, Lt. Governor Feliciano Perman, State Senator Casinda Ludwig from Kapingamarangi, MCT Executive Director William Kostka, and Japanese Ambassador Sobashima Hidenobu, among about 40 participants.

Mr. Kostka explained how this assistance had become possible, and about APIC.

Ambassador Sobashima, having referred to the cooperation to the FSM both from the Government and private organizations of Japan, including APIC, introduced the message from Ambassador Peter Sato, President of APIC as follows: "We are pleased to work with the Micronesia Conservation Trust to help alleviate suffering caused by the droughts on Kapingamarangi and on Weno. The 18 water tanks purchased and installed at the strategic locations will reduce the likelihood that the next drought will cause so much suffering."

Ambassador Sobashima concluded that

to the diabetes community while keeping diabetes firmly in the spotlight. In the FSM, though the estimated number of diabetic patients based on prevalence (25 years old and above) is about 14,762, only 3,918 people representing nearly 27% are currently registered and receiving regular care. The National NCD Program is concerned about this phenomenon and therefore actively sensitizing the public to undergo voluntary periodic screening so they can manage their own health conditions including receiving the right available care.

The organizers of the event, while acknowledging the immense contributions of all volunteers and supporters, have undertaken to make free health screening a part of all future World Diabetes Day celebrations in the FSM.

Digital Atlas of Micronesia advances FSM data beyond Guam, Hawaii

University of Guam

With the culmination of a five-year effort to gather a breadth of geospatial data and display it on an interactive digital atlas, the four main islands of the Federated States of Micronesia are now more easily researched than any other island in the Pacific, including Hawaii, Guam, and Fiji.

The Digital Atlas of Micronesia launched on Nov. 1 and is a free and available resource for anyone to use at <https://islandatlas.org>. It currently covers Yap proper, Chuuk Lagoon, Pohnpei, and Kosrae.

The atlas is a collaborative project among Island Research & Education Initiative, or iREi, a nonprofit organization located in Pohnpei; the FSM Department of Environment, Climate Change, and Emergency Management; and the Water and Environmental Research Institute at the University of Guam and was funded by the U.S. Geological Survey and the FSM National Government.

"We have gone way above and beyond the initial vision, and we now have, by far, the most comprehensive and versatile 'national' geospatial data repository anywhere in the Pacific Islands," said Danko Taboroši, chief editor of the atlas and director of Island Research & Education Initiative. "iREi and WERI created our first digital atlas for Guam in 2009. What we did for the FSM benefited from that experience and loads of new data and improved technologies over the past 10 years."

Fishermen wanting to know the boundaries of marine preserves, tourists interested in seeing historical and cultural sites, a contractor needing to bury new utility lines, a student needing demographics for a particular set of villages for a project, a diver looking for shipwreck sites, or a biologist wanting to find areas with specific vegetation — it's all searchable on the digital atlas. Users can customize a map for their purposes and then export or print it.

"There's a lot of information contained in this atlas that — if you just have it in text or table form, it's really hard to comprehend, but if you look at these maps and graphics, they really tell a story," said Maria Kottermair, a UOG WERI alumna and geographic information specialist who

is co-editor of the atlas. "We discovered and digitized old, hard-to-find maps, information from the population census ... we even located and digitized maps from a number of historical documents and master's and Ph.D. theses and produced a range of layers representing cultural and historical heritage of the FSM."

The digital atlas features nearly 500 pre-designed static maps, which can be found in the "Gallery," as well as interactive maps for each island with 400 layers that can be toggled on and off. The optional map layers include:

- cultural sites
- conservation areas
- infrastructure, including quarries, wells and water lines, and building footprints
- population demographics
- vegetation cover
- rainfall and waterflow
- reef information
- land characteristics, including elevation, slope degree, soil types, and geology.

"To document this much vetted information in one place — especially for a remote area like Micronesia — is a major feat," said John W. Jenson, director of the Water and Environmental Research Institute at UOG, which helped secure the core funding and provided oversight of the project. "This atlas is an efficient and accessible source of scientifically informed data, and that's the kind of project WERI is always proud to support."

The atlas can be used for a variety of purposes, including sustainable development, effective management of natural resources and infrastructure, emergency response, research, as an education and teaching tool, for general public awareness, and for business as well. It is designed to be user-friendly and intuitive.

"It's a living project, and we intend to keep updating it as new data become available," Kottermair said. "I encourage everyone to just go to the atlas and explore."

The team will work next on including the outer islands of the FSM in the atlas and to rebuild Guam's digital atlas at hydroguam.net, which Kottermair said has been a popular resource but has become outdated.

Elizabeth, one of the beneficiaries of the free screening said, "I've been wanting to see an eye doctor for over 6 months and when I heard that this screening would happen, I prioritized coming here today."

In his brief remarks, the NCD Program Manager for FSM Mr. X-ner Luther underscored the need for routine health screening by people as it is an important entry point for case management and care. "There is an ongoing effort to bring the concept of 'public' back into 'public health'. It is not just about services but rather ensuring that we as a community are aware of what we can collectively do to deter the increasing trend of diabetes and other non-communicable diseases," said Mr. Luther.

World Diabetes Day (WDD) was founded in 1991 by the International Diabetes Federation and the World Health Organization in response to growing concerns about the increasing health threat posed by diabetes. It is also the world's biggest diabetes awareness campaign that requires countries, particularly those with high disease burdens, to draw attention to issues of critical importance
